1.6	Section 1. Minnesota Statutes 2012, section 383E.21, subdivision 1, is amended to read:
1.7	Subdivision 1. Authority to levy property taxes and incur debt. (a) To finance the
1.8	cost of designing, constructing, and acquiring countywide public safety improvements
1.9	and equipment, including personal property, benefiting both Anoka County and the
1.10	municipalities located within Anoka County, the governing body of Anoka County may
1.11	levy property taxes for public safety improvements and equipment, and issue:
1.12	(1) capital improvement bonds under the provisions of section 373.40 as if the
1.13	infrastructure and equipment qualified as a "capital improvement" within the meaning of
1.14	section 373.40, subdivision 1, paragraph (b); and
1.15	(2) capital notes under the provisions of section 373.01, subdivision 3, as if the
1.16	equipment qualified as "capital equipment" within the meaning of section 373.01,
1.17	subdivision 3. Personal property acquired with the proceeds of the bonds or capital
1.18	notes issued under this section must have an expected useful life at least as long as the
1.19	term of debt.
1.20	(b) The outstanding principal amount of the bonds and the capital notes issued under
1.21	this section may not exceed \$8,000,000 at any time. Any bonds or notes issued pursuant
1.22	to this section must only be issued after approval by a majority vote of the Anoka County
1.23	Joint Law Enforcement Council, a joint powers board.
