(a) The Board of Teaching, in collaboration with education faculty at the Minnesota
State University, Mankato; licensed career and technical education teachers; employers
participating in cooperative career and technical education programs; other providers of
project-based learning opportunities; and other interested education, teacher preparation,
and work-related stakeholders, must develop and submit to the education committees of the
legislature by February 1, 2019, a proposal to implement a research-based, results-oriented
teacher preparation curriculum focused on the knowledge and skills teachers need to
effectively provide and facilitate project-based learning.
