1.8	Subdivision 1. Appropriation. (a) \$1,400,000 is appropriated from the bond proceeds
1.9	fund to the commissioner of natural resources for the state share of flood hazard mitigation
1.10	grants for publicly owned capital improvements to prevent or alleviate flood damage under
1.11	Minnesota Statutes, section 103F.161.
1.12	(b) Levee projects, to the extent practical, shall meet the state standard of three feet
1.13	above the 100-year flood elevation.
1.14	(c) Project priorities shall be determined by the commissioner as appropriate and based
1.15	on need.
1.16	(d) This appropriation is for the 220th Street flood damage reduction project in the

2.4	Subd. 2. Bond sale. To provide the money appropriated in this section from the bond
2.5	proceeds fund, the commissioner of management and budget shall sell and issue bonds of
2.6	the state in an amount up to \$1,400,000 in the manner, upon the terms, and with the effect
2.7	prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota
