1.10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.11 Section 1. Minnesota Statutes 2014, section 115A.1310, subdivision 6, is amended to  
 1.12 read:

1.13 Subd. 6. **Computer monitor.** "Computer monitor" means an electronic device that  
 1.14 is a cathode-ray tube or flat panel display primarily intended to display information from a  
 1.15 central processing unit or the Internet. ~~Computer monitor includes a laptop computer.~~

1.16 Sec. 2. Minnesota Statutes 2014, section 115A.1310, subdivision 7, is amended to read:

1.17 Subd. 7. **Covered electronic device.** "Covered electronic device" means computers,  
 1.18 including tablet computers and laptop computers, peripherals, facsimile machines, DVD  
 1.19 players, video cassette recorders, and video display devices that are sold to a household by  
 1.20 means of retail, wholesale, or electronic commerce.

1.21 Sec. 3. Minnesota Statutes 2014, section 115A.1310, is amended by adding a  
 1.22 subdivision to read:

1.23 Subd. 12a. **Portable battery.** "Portable battery" means a rechargeable battery  
 1.24 as defined in section 115A.9157.

2.1 **EFFECTIVE DATE.** This section is effective July 1, 2016.

2.2 Sec. 4. Minnesota Statutes 2014, section 115A.1310, is amended by adding a  
2.3 subdivision to read:

2.4 **Subd. 12b. Phase I recycling credits.** "Phase I recycling credits" means the number  
2.5 of pounds of covered electronic devices recycled by a manufacturer from households  
2.6 during program years one through nine, less the product of the number of pounds of  
2.7 video display devices sold to households during the same program year, multiplied by the  
2.8 proportion of sales a manufacturer is required to recycle.

2.9 Sec. 5. Minnesota Statutes 2014, section 115A.1310, is amended by adding a  
2.10 subdivision to read:

2.11 **Subd. 12c. Phase II recycling credits.** "Phase II recycling credits" means the  
2.12 number of pounds of covered electronic devices recycled by a manufacturer during a  
2.13 program year beginning July 1, 2019, and thereafter, from households located outside  
2.14 the 11-county metropolitan area, as defined in section 115A.1314, subdivision 2, less  
2.15 the manufacturer's recycling obligation calculated for the same program year in section  
2.16 115A.1320, subdivision 1, paragraph (g).

2.17 Sec. 6. Minnesota Statutes 2014, section 115A.1310, subdivision 20, is amended to read:

2.18 **Subd. 20. Video display device.** "Video display device" means a television or  
2.19 computer monitor, ~~including a laptop computer,~~ that contains a cathode-ray tube or a flat  
2.20 panel screen ~~with a screen size that is greater than nine inches measured diagonally and~~  
2.21 that is marketed by manufacturers for use by households. Video display device does  
2.22 not include any of the following:

2.23 (1) a video display device that is part of a motor vehicle or any component part of a  
2.24 motor vehicle assembled by, or for, a vehicle manufacturer or franchised dealer, including  
2.25 replacement parts for use in a motor vehicle;

2.26 (2) a video display device, including a touch-screen display, that is functionally or  
2.27 physically part of a larger piece of equipment or is designed and intended for use in an  
2.28 industrial; commercial, including retail; library checkout; traffic control; kiosk; security,  
2.29 other than household security; border control; or medical setting, including diagnostic,  
2.30 monitoring, or control equipment;

2.31 (3) a video display device that is contained within a clothes washer, clothes dryer,  
2.32 refrigerator, refrigerator and freezer, microwave oven, conventional oven or range,  
2.33 dishwasher, room air conditioner, dehumidifier, or air purifier; or

3.5 Subd. 2. **Manufacturer's registration.** (a) By August 15 each year, a manufacturer  
3.6 of video display devices sold or offered for sale to households ~~after September 1, 2007,~~ in  
3.7 the state must submit a registration to the agency that includes:

3.8 (1) a list of the manufacturer's brands of video display devices offered for sale in  
3.9 this state;

3.10 (2) the name, address, and contact information of a person responsible for ensuring  
3.11 compliance with this chapter; and

3.12 (3) a certification that the manufacturer has complied and will continue to comply  
3.13 with the requirements of sections 115A.1312 to 115A.1318.

3.14 (b) ~~By September 1, 2008, and each year thereafter,~~ A manufacturer of video display  
3.15 devices sold or offered for sale to a household must include in the registration submitted  
3.16 under paragraph (a), a statement disclosing whether:

3.17 (1) any video display devices sold to households exceed the maximum concentration  
3.18 values established for lead, mercury, cadmium, hexavalent chromium, polybrominated  
3.19 biphenyls (PBB's), and polybrominated diphenyl ethers (PBDE's) under the RoHS  
3.20 (restricting the use of certain hazardous substances in electrical and electronic equipment)  
3.21 Directive 2002/95/EC of the European Parliament and Council and any amendments  
3.22 thereto; or

3.23 (2) the manufacturer has received an exemption from one or more of those maximum  
3.24 concentration values under the RoHS Directive that has been approved and published by  
3.25 the European Commission.

3.26 (c) A manufacturer who begins to sell or offer for sale video display devices to  
3.27 households ~~after September 1, 2007~~ August 15, 2016, and has not filed a registration under  
3.28 this subdivision must submit a registration to the agency within ten days of beginning to  
3.29 sell or offer for sale video display devices to households.

3.30 (d) A registration must be updated within ten days after a change in the  
3.31 manufacturer's brands of video display devices sold or offered for sale to households.

3.32 (e) A registration is effective upon receipt by the agency and is valid until ~~September~~  
3.33 ~~1~~ of August 15 each year.

3.34 (f) The agency must review each registration and notify the manufacturer of any  
3.35 information required by this section that is omitted from the registration. Within 30 days

4.1 of receipt of a notification from the agency, the manufacturer must submit a revised

4.3 (g) The agency must maintain on its Web site the names of manufacturers and the  
4.4 manufacturers' brands listed in registrations filed with the agency. The agency must  
4.5 update the Web site information promptly upon receipt of a new or updated registration.  
4.6 The Web site must contain prominent language stating, in effect, that sections 115A.1310  
4.7 to 115A.1330 are directed at household equipment and the manufacturers' brands list is,  
4.8 therefore, not a list of manufacturers qualified to sell to industrial, commercial, or other  
4.9 markets identified as exempt from the requirements of sections 115A.1310 to 115A.1330.

4.13 collector of covered electronic devices from households unless that person has submitted a  
4.14 registration with the agency by July 15 each year on a form prescribed by the commissioner.  
4.15 Registration information must include the name, address, telephone number, and location  
4.16 of the business and a certification that the collector has complied and will continue to  
4.17 comply with the requirements of sections 115A.1312 to 115A.1318 and any regulations  
4.18 adopted by a local government unit for the jurisdiction in which the collector operates. A  
4.19 collector must indicate any end-of-life fees that will be charged at the collection point. A  
4.20 registration is effective upon receipt by the agency and is valid until July ~~1~~ of 15 each year.

4.21 **EFFECTIVE DATE.** This section is effective July 1, 2016.

4.22 Sec. 9. Minnesota Statutes 2014, section 115A.1312, subdivision 4, is amended to read:

4.23 Subd. 4. **Recycler's registration.** ~~After August 1, 2007,~~ No person may recycle  
4.24 video display devices generated by households unless that person has submitted  
4.25 a registration with the agency by July 15 each year on a form prescribed by the  
4.26 commissioner. Registration information must include the name, address, telephone  
4.27 number, and location of all recycling facilities under the direct control of the recycler that  
4.28 may receive ~~video display~~ covered electronic devices from households and a certification  
4.29 that the recycler has complied and will continue to comply with the requirements of  
4.30 sections 115A.1312 to 115A.1318. A registered recycler ~~may~~ must conduct recycling  
4.31 activities that are consistent with this chapter. A registration is effective upon receipt by  
4.32 the agency and is valid until July ~~1~~ of 15 each year.

5.5 commissioner of revenue an annual registration fee, on a form and in a manner prescribed  
5.6 by the commissioner of revenue. The commissioner of revenue must deposit the fee in the  
5.7 state treasury and credit the fee to the environmental fund.

5.8 (b) The registration fee for manufacturers that sell 100 or more video display  
5.9 devices to households in the state during the previous calendar year is equal to a base fee

7.22 (i) the total weight of its video display devices sold to households during the  
 7.23 previous program year; or

7.24 (ii) an estimate of the total weight of its video display devices sold to households  
 7.25 during the previous program year, calculated by multiplying the weight of its video  
 7.26 display devices sold nationally times the quotient of Minnesota's population divided by  
 7.27 the national population. All manufacturers with sales of 99 or fewer video display devices  
 7.28 to households in the state during the previous calendar year must report using the method

9.24 (b) A manufacturer must annually recycle or arrange for the collection and recycling  
 9.25 of an amount of ~~covered electronic~~ video display devices equal to the total weight of its  
 9.26 ~~video display devices sold to households during the preceding program year, multiplied by~~  
 9.27 ~~the proportion of sales of video display devices required to be recycled, as established~~

 10.2 from households and do not apply to video display devices received from sources other  
 10.3 than households.

10.4 (d) A manufacturer must conduct and document due diligence assessments of  
 10.5 collectors and recyclers it contracts with, including an assessment of items specified under  
 10.6 subdivision 2. A manufacturer is responsible for maintaining, for a period of three years,  
 10.7 documentation that all ~~video display~~ covered electronic devices recycled, partially recycled,  
 10.8 or sent to downstream recycling operations comply with the requirements of subdivision 2.

10.9 (e) A manufacturer must provide the agency with contact information for a person  
 10.10 who can be contacted regarding the manufacturer's activities under sections 115A.1310  
 10.11 to 115A.1320.

10.12 (f) Only the covered electronic devices that are recycled by a registered recycler  
 10.13 that is certified by an ANSI-ASQ National Accreditation Board-accredited third-party  
 10.14 certification body to an environmentally sound management standard are eligible to meet

**115A.1310 DEFINITIONS.**

Subd. 16. **Recycling credits.** "Recycling credits" means the number of pounds of covered electronic devices recycled by a manufacturer from households during a program year, less the product of the number of pounds of video display devices sold to households during the same program year, multiplied by the proportion of sales a manufacturer is required to recycle. The calculation and uses of recycling credits are as specified in section 115A.1314, subdivision 1.
