(1) make direct payments of state grant refunds in excess of tuition and fees to students
at their last known addresses;
(2) make direct payments of postsecondary child care grant awards to students at their
last known addresses;
(3) reverse disbursements of SELF loans made on or after January 1, 2019;
(4) reverse disbursements of SELF loans to settle any unresolved refunds due to the
lender; and
(5) inform recipients of an Indian scholarship or GI Bill award that they have the option
to request payments directly and, where applicable, make such payments to the students.
