 2.4 items in dispute and recommend as follows:

2.5 That the Senate recede from its amendments and that H. F. No. 2887 be further amended
 2.6 as follows:

2.10 Section 1. **TRANSPORTATION APPROPRIATIONS.**

2.11 The sums shown in the columns marked "Appropriations" are appropriated to the agencies
 2.12 and for the purposes specified in this article. The appropriations are from the trunk highway
 2.13 fund, or another named fund, and are available for the fiscal years indicated for each purpose.
 2.14 Amounts for "Total Appropriation" and sums shown in the corresponding columns marked
 2.15 "Appropriations by Fund" are summary only and do not have legal effect. Unless specified
 2.16 otherwise, the amounts in fiscal year 2025 under "Appropriations by Fund" show the base
 2.17 within the meaning of Minnesota Statutes, section 16A.11, subdivision 3, by fund. The
 2.18 figures "2024" and "2025" used in this article mean that the appropriations listed under them
 2.19 are available for the fiscal year ending June 30, 2024, or June 30, 2025, respectively. "Each
 2.20 year" is each of fiscal years 2024 and 2025. "The biennium" is fiscal years 2024 and 2025.
 2.21 "C.S.A.H." is the county state-aid highway fund. "M.S.A.S." is the municipal state-aid street
 2.22 fund. "H.U.T.D." is the highway user tax distribution fund. "Staff" means those employees
 2.23 who are identified in any of the following roles for the legislative committees: committee
 2.24 administrator, committee legislative assistant, caucus research, fiscal analysis, counsel, or
 2.25 nonpartisan research.

190.20 (d) "Federal grant recipient" means an entity that receives a federal discretionary grant

190.22 Subd. 2. **General requirements.** (a) The commissioner must establish a process to

190.24 (b) The commissioner must allocate available funds in the order of (1) requests submitted
190.25 by federal grant recipients, followed by (2) announcement or notification of the federal
190.26 grant award. The commissioner may allocate funds for a federal discretionary grant awarded

190.28 (c) The commissioner must only allocate available funds:

- 194.12 **Subd. 5. Duties.** (a) In collaboration with the participating organizations under subdivision

196.3 **EFFECTIVE DATE; APPLICATION.** This section is effective the day following
196.4 final enactment and applies in the counties of Anoka, Carver, Dakota, Hennepin, Ramsey,
196.5 Scott, and Washington.

196.6 **Sec. 116. BLUE LINE LIGHT RAIL EXTENSION ENGAGEMENT MEETINGS.**

196.7 (a) The Blue Line light rail extension project office must, at least quarterly, organize
196.8 and facilitate community engagement meetings in consultation with community groups
196.9 located along the Blue Line extension alignment route, primarily focused on Minneapolis
196.10 neighborhoods, including the Lyn-Park, Willard-Hay, Near North, and Jordan communities.
196.11 Information requested by community groups in the meetings or in correspondence to the
196.12 project office must be supplied in a timely manner and, if practicable, before the next
196.13 quarterly meeting. Information, concerns, and requests presented by the community at the

199.11 trails from the current eastern terminus of the Midtown Greenway in Hennepin County to
199.12 27th Avenue Southeast in Hennepin County and to Allianz Field in Ramsey County. The
