Minnesota Statutes 2016, section 609.684, is amended by adding a subdivision 1.6 to read: 1.7 Subd. 2a. Sale of products containing DFE to minors prohibited. (a) A person is 1.8 guilty of a petty misdemeanor who sells a product containing 1,1-difluoroethane (DFE) to 1.9 a person under the age of 18. 1.10 (b) It is an affirmative defense to a charge under this subdivision if the defendant proves 1.11 by a preponderance of the evidence that the defendant reasonably and in good faith relied 1.12 on proof of age as described in section 340A.503, subdivision 6. 1.13 EFFECTIVE DATE. This section is effective August 1, 2018, and applies to acts 1.14
