1.8	Subdivision 1. Location; timing. An eligible voter may vote by absentee ballot in
1.9	the office of the county auditor and at any other polling place designated by the county
1.10	auditor during the 46 days before the election, except as provided in this section.
1.11	Subd. 2. Town elections. Voters casting absentee ballots in person for a town
1.12	election held in March may do so during the 30 days before the election. The county
1.13	auditor shall make such designations at least 14 weeks before the election. At least one
1.14	voting booth in each polling place must be made available by the county auditor for
1.15	this purpose. The county auditor must also make available at least one electronic ballot
1.16	marker in each polling place that has implemented a voting system that is accessible for
