1.9	Subd. 6. Transportation network company. Data obtained by the commissioner from
1.10	a transportation network company is governed by section 325F.663, subdivision 11.
1.11	Sec. 2. Minnesota Statutes 2016, section 221.012, subdivision 38, is amended to read:
1.12	Subd. 38. <b>Small vehicle passenger service.</b> (a) "Small vehicle passenger service" means
1.13	a service provided by a person engaged in the for-hire transportation of passengers in a
1.14	vehicle designed to transport seven or fewer persons, including the driver.
1.15	(b) In the metropolitan area as defined in section 473.121, subdivision 2, "small vehicle

2.2	Subdivision 1. Definitions. (a) For purposes of this section, the following terms have

5.8	(3) soliciting or accepting cash payments for a fare from a rider.
5.9	(b) A driver must display a consistent and distinctive sign or emblem, that has been
5.10	approved by the commissioner, on the TNC vehicle at all times while the driver is active
5.11	on the digital network. The sign or emblem must:
5.12	(1) be sufficiently large and color-contrasted to be readable during daylight hours from
5.13	a distance of at least 50 feet;
5.14	(2) be reflective, illuminated, or otherwise visible in dark conditions; and
5.15	(3) sufficiently identify a TNC vehicle as being associated with the transportation network

5.17	(c) A driver may refuse to transport a rider if the rider acts in an unlawful, disorderly,
5.18	or endangering manner.
5.19	(d) Upon request of a peace officer, a driver must display digital identification and
5.20	electronic evidence that the rider was matched through the digital network. If the information
5.21	described in this paragraph is contained on an electronic device, the driver is not required
5.22	to relinquish possession of the electronic device.
5.23	Subd. 7. TNC vehicle requirements. (a) Before permitting a TNC vehicle to be used
5.24	to provide prearranged rides, a transportation network company must conduct or confirm
5.25	that the TNC vehicle has undergone and passed a safety inspection.
5.26	(b) At a minimum, the safety inspection must evaluate the following components of the
5.27	vehicle:
5.28	(1) brake system;
5.29	(2) parking brakes;
5.30	(3) steering mechanism;

6.21	transportation network company's intoxicating substance policy and include a means for a
6.22	rider or another individual to submit a complaint regarding a suspected violation of the
6.23	policy.
6.24	(b) Upon receipt of a rider complaint alleging a violation of the intoxicating substance
6.25	policy, the transportation network company must immediately suspend the driver's access
6.26	to the digital network and conduct an investigation into the reported incident. At a minimum
6.27	the suspension must last for the duration of the investigation.
6.28	Subd. 9. Nondiscrimination and accessibility. (a) A transportation network company
6.29	must implement a policy that prohibits discrimination on the basis of destination, race, color
6.30	national origin, religious belief or affiliation, sex, disability, age, sexual orientation, or

gender identity with respect to all potential riders. The policy must also prohibit drivers
from refusing to provide service to an individual with a service animal.
(b) A transportation network company must notify all drivers of the nondiscrimination
policy. All drivers must comply with the nondiscrimination policy.
(c) A transportation network company is prohibited from imposing any additional charge
on a rider with a physical disability because of the disability.
(d) A transportation network company must provide a rider an opportunity to indicate
whether the rider requires a wheelchair-accessible vehicle. If a wheelchair-accessible vehicle
cannot be provided, the transportation network company must direct the requesting rider to
an alternate provider of wheelchair-accessible service, if one is available.
Subd. 10. Records; retention. (a) A transportation network company must maintain
records documenting compliance with the requirements of this section for two years from
the date of documentation.
(b) The commissioner must provide an electronic means to submit all data required
under this section.
Subd. 11. <b>Data practices; liability.</b> (a) Data disclosed to the commissioner by a
transportation network company, including the names, addresses, and any other personally
identifiable information of drivers or riders, is nonpublic data or private data on individuals
as defined in section 13.02, subdivisions 9 and 12. If data provided to the commissioner
pursuant to this section is sought through a court order or subpoena, the commissioner must
promptly notify the transportation network company. If there is a breach of the security of
the data as provided under section 13.055, the commissioner must notify the transportation
network company in the same manner as provided for individuals under that section.

(b) A transportation network company is not civilly or criminally liable for a violation
of chapter 13 by the commissioner.
Subd. 12. Uniform statewide regulation. (a) This section applies uniformly throughout
the state and in all political subdivisions.

subdivision that specifically governs transportation network companies, drivers, or TNC
