1.8	Section 1. Minnesota Statutes 2014, section 161.081, subdivision 3, is amended to read:
1.9	Subd. 3. Flexible highway account; turnback accounts. (a) The flexible highway
1.10	account is created in the state treasury. Money in the account shall be used:
1.11	(1) in fiscal years 2009 and 2010, 100 percent of the excess sum, as calculated in
1.12	paragraph (i), and in fiscal years 2011 and thereafter, 50 percent of the excess sum, as
1.13	calculated in paragraph (i), for counties in the metropolitan area, as defined in section
1.14	473.121, subdivision 4, but for the purposes of the calculation cities of the first class will
1.15	be excluded in the metropolitan area; and
1.16	(2) of the amount available in the flexible highway account less the amount under

(c) The commissioner shall review the need for funds to restore highways that have 2.3 been or will be turned back. The commissioner shall determine, on a biennial basis, the 2.4 percentage of funds in the flexible highway account to be distributed to each district, 2.5 and within each district the percentage to be used for each of the purposes specified in 2.6 paragraph (a). Money in the account may be used for safety improvements and routes of 2.7 regional significance only after money is set aside to restore the identified turnbacks. The 28 commissioner shall make these determinations only after meeting and holding discussions 2.9 with committees selected by the statewide associations of both county commissioners and 2.10 municipal officials. The commissioner shall, to the extent feasible, annually allocate 50 2.11 percent of the funds in the flexible highway account to the department's metropolitan 2.12 district, and 50 percent to districts in greater Minnesota. 2.13

(d) Money that will be used for the restoration of trunk highways that have reverted
or that will revert to cities must be deposited in the municipal turnback account, which is
created in the state treasury.

(e) Money that will be used for the restoration of trunk highways that have reverted
or that will revert to counties must be deposited in the county turnback account, which is
created in the state treasury.

(f) Money that will be used for safety improvements must be deposited in the
highway safety improvement account, which is created in the state treasury to be used
as grants to statutory or home rule charter cities, towns, and counties to assist in paying
the costs of constructing or reconstructing city streets, county highways, or town roads
to reduce crashes, deaths, injuries, and property damage.

(g) Money that will be used for routes of regional significance must be deposited in
the routes of regional significance account, which is created in the state treasury, and used
as grants to statutory or home rule charter cities, towns, and counties to assist in paying
the costs of constructing or reconstructing city streets, county highways, or town roads
with statewide or regional significance that have not been fully funded through other state,
federal, or local funding sources.

(h) As part of each biennial budget submission to the legislature, the commissioner
shall describe how the money in the flexible highway account will be apportioned among
the county turnback account, the municipal turnback account, the trunk highway fund for
routes turned back to local governments by agreement, the highway safety improvement
account, and the routes of regional significance account.
