1.29 Renumber the sections in sequence

1.30 Amend the title as follows:

1.31 Page 1, delete lines 2 to 4

1.32 Page 1, line 5, delete everything before "amending" and insert "relating to
1.33 transportation; modernizing provisions governing motor vehicles; eliminating certain

- 2.1 antiquated, unnecessary, and obsolete provisions; making technical and conforming
- 2.2 changes;"
- 2.3 Correct the title numbers accordingly
