

1.11 The commissioner shall approve a request to be a workforce service development
1.12 area from:

(1) a home rule charter or statutory city with a population of 200,000 or more or a
county with a population of 200,000 or more; or

1.15 (2) a consortium of contiguous home rule charter or statutory cities or counties

- with an aggregate population of 200,000 or more that serves a substantial part of one ormore labor markets.
- 1.18 The commissioner may approve a request to be a workforce <u>service_development</u> 1.19 area from a home rule charter or statutory city or a county or a consortium of contiguous 1.20 home rule charter or statutory cities or counties, without regard to population, that serves a 1.21 substantial portion of a labor market area.

 The commissioner shall make a final designation of workforce service development
- areas within the state after consulting with local elected officials and the governor's

designated under the federal Job Training Partnership Workforce Investment Act shall

be initially designated as workforce service development areas providing that no other
petitions are submitted by local elected officials.

2.4 The commissioner may redesignate workforce service development areas, upon the
2.5 advice of the affected local elected officials, no more frequently than every two years.
2.6 These redesignations must be made not later than four months before the beginning of a
2.7 program year.

Subd. 2. Creation of local workforce councils development boards. A local
workforce council development board must be established in each workforce service
development area, designated according to subdivision 1.

2.11 Subd. 3. **Membership on local workforce** councils <u>development boards</u>. In 2.12 workforce <u>service development</u> areas representing only one home rule charter or statutory 2.13 city or a county, the chief <u>local</u> elected official must appoint members to the <u>council board</u>. 2.14 In workforce <u>service development</u> areas representing two or more home rule charter or 2.15 statutory cities or counties, the chief elected officials of the home rule charter or statutory 2.16 cities or counties must appoint members to the <u>council board</u>, in accordance with an 2.17 agreement entered into by such units of general local government.

A council local workforce development board shall include as members:

(1) representatives of the private sector, who must constitute a majority of the
membership of the <u>council workforce development board</u> and who are owners of business
concerns, chief executives or chief operating officers of nongovernmental employers, or
other private sector executives who have substantial management or policy responsibility;

(2) at least two representatives of organized labor;

2.24 (3) representatives of the area workforce and community-based organizations,
2.25 including labor, veterans, individuals with disabilities, minorities, older workers, housing,
2.26 secondary career and technical education, or philanthropic organizations, who shall

- (i) <u>higher</u> educational agencies that are representative of all <u>higher</u> educational
 agencies within the workforce <u>service</u> <u>development</u> area, <u>including community colleges</u>;
 (ii) vocational rehabilitation <u>agencies</u> programs carried out under title I of the
 Rehabilitation Act of 1973 within the workforce development area;

| 3.10 | Private sector representatives on the local workforce eouncil development board shall |
| 3.11 | be selected from among individuals nominated by general purpose business organizations, |
| 3.12 | such as local chambers of commerce, in the workforce service development area. |
| 3.13 | Education representatives on the local workforce eouncil development board must |
| 3.14 | include at least one representative from a local adult basic education program approved |
| 3.15 | under section 124D.52 and nominated by the program, and the remaining higher education |
| 3.16 | representatives shall be selected from among individuals nominated by secondary and |
| 3.17 | postsecondary educational institutions within the workforce service development area. |
| 3.18 | Organized labor representatives on the local workforce eouncil development |
| 3.19 | board shall be selected from individuals recommended by recognized state and local |
| 3.20 | labor federations, organizations, or councils. If the state or local labor federations, |
| 3.21 | organizations, or councils fail to nominate a sufficient number of individuals to meet |

| 3.24 | The commissioner must certify a local workforce council development board if |

| 3.27 | Subd. 4. Purpose; duties of local workforce council development board. The |
| 3.28 | local workforce eouncil_development board is responsible for providing policy guidance |
| 3.29 | for, and exercising oversight with respect to, activities conducted by local workforce |
| 3.30 | centers in partnership with the local unit or units of general local government within the |
| 3.31 | workforce service development area and with the commissioner. |
| 3.32 | A local workforce center is a location where federal, state, and local employment |
| 2.22 | and training carviage are provided to job cockers and employers |

3.34 A local workforce <u>eouncil development board</u>, in accordance with an agreement or
