1.1 A bill for an act
1.2 relating to public safety; establishing a crime for misrepresenting an animal as a
1.3 service animal; proposing coding for new law in Minnesota Statutes, chapter 609.

1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. **[609.833] MISREPRESENTATION OF SERVICE ANIMAL.**

1.6 Subdivision 1. **Definitions.** As used in this section:

1.7 (1) "place of public accommodation" has the meaning given in section 363A.03,
1.8 subdivision 34; and

1.9 (2) "service animal" has the meaning given in Code of Federal Regulations, title 28,
1.10 section 36.104, as amended through March 1, 2018.

1.11 Subd. 2. **Prohibited conduct.** A person may not, directly or indirectly through statements
1.12 or conduct, intentionally misrepresent an animal in that person's possession as a service
1.13 animal in any place of public accommodation to obtain any rights or privileges available
1.14 to a person who qualifies for a service animal under state or federal law knowing that the
1.15 person is not entitled to those rights or privileges.

1.16 Subd. 3. **Penalty.** (a) Except as provided in paragraph (b), a person who violates
1.17 subdivision 2 is guilty of a petty misdemeanor.

1.18 (b) A person who violates subdivision 2 a second or subsequent time is guilty of a
1.19 misdemeanor.

2.1 Subd. 4. Notice. (a) A conspicuous sign may be posted in a location accessible to public
2.2 view in a place of public accommodation that contains the following, or substantially similar,
2.3 language:

2.4 "NOTICE

2.5 Service Animals Welcome. It is illegal for a person to misrepresent an animal in that
2.6 person's possession as a service animal."

2.7 (b) The Council on Disability may prepare and make available to businesses a brochure
2.8 detailing permissible questions a business owner may ask to determine whether an animal
2.9 is a service animal, proper answers to those questions, and guidelines defining unacceptable
2.10 behavior.

2.11 **EFFECTIVE DATE.** This section is effective August 1, 2018, and applies to acts
2.12 committed on or after that date.
