1.6	Section 1. COVID-19 PUBLIC HEALTH DISASTER RESPONSE.
1.7	Subdivision 1. COVID-19 response powers. The state's COVID-19 public health
1.8	response is governed by this act, as of the effective date of this section. The powers granted
1.9	to the governor under Minnesota Statutes, chapter 12, do not apply to the COVID-19
1.10	infectious disease outbreak unless explicitly authorized by this section or subsequent
1.11	legislative enactment.
1.12	Subd. 2. Public health disaster declaration; eligibility for federal assistance. (a)

1.16	providing public health services or enforcing existing health and human services laws, as
