Section 1. **DEPARTMENT OF CORRECTIONS.**

The amounts in this section are appropriated from the general fund to the commissioner of corrections in fiscal year 2015 for full and final payment under Minnesota Statutes, sections 3.738 and 3.739, of claims against the state for losses suffered while incarcerated in a state correctional facility or for injuries suffered by and medical services provided to persons injured while performing community service or sentence-to-service work for correctional purposes or while incarcerated in a state correctional facility. This appropriation is available until June 30, 2015:

- (1) for sentence-to-service and community work service claims under \$500 and other claims already paid by the department, \$2,359.82;
- (2) for payment to Garry Green for permanent injuries to his right hand sustained while performing sentence to service work in Hennepin County, \$7,400;
- (3) for payment to David Huff for permanent injuries to his back sustained while performing sentence to service work in Waseca County and for medical costs incurred by Mr. Huff, \$19,686.22, and to medical providers for treatment of Mr. Huff, \$9,065.24;
