1.9	activated that is parked or otherwise stopped on or next to a street or highway having two
1.10	lanes in the same direction, the driver of a vehicle shall safely move the vehicle to the lane
1.11	farthest away from the emergency vehicle, if it is possible to do so.
1.12	(b) When approaching and before passing an authorized emergency vehicle with its
1.13	emergency lights activated that is parked or otherwise stopped on or next to a street or

2.1 (e) (d) A peace officer may issue a citation to the driver of a motor vehicle if the peace 2.2 officer has probable cause to believe that the driver has operated the vehicle in violation of 2.3 this subdivision within the four-hour period following the termination of the incident or a 2.4 receipt of a report under paragraph (d) (e). The citation may be issued even though the 2.5 violation was not committed in the presence of the peace officer.

Subd. 12. **Passing certain parked vehicles.** (a) When approaching and before passing a freeway service patrol vehicle, road maintenance vehicle, utility company vehicle, or construction vehicle with its warning lights activated that is parked or otherwise stopped on or next to a street or highway having two lanes in the same direction, the driver of a vehicle shall safely move the vehicle to the lane farthest away from the parked or stopped vehicle, if it is possible to do so.

(b) When approaching and before passing a freeway service patrol vehicle, road
maintenance vehicle, utility company vehicle, or construction vehicle with its warning lights
activated that is parked or otherwise stopped on or next to a street or highway having more
than two lanes in the same direction, the driver of a vehicle shall safely move the vehicle
so as to leave a full lane vacant between the driver and any lane in which the vehicle is
completely or partially parked or otherwise stopped, if it is possible to do so.

(c) If a lane change under paragraph (a) or (b) is impossible, or when approaching and
 before passing a freeway service patrol vehicle, road maintenance vehicle, utility company
 vehicle, or construction vehicle with its warning lights activated that is parked or otherwise
