1.19 ARTICLE 1

1.20 SUPPLEMENTAL APPROPRIATIONS

1.21 Section 1. APPROPRIATIONS.

1.22 The sums shown in the columns marked "Appropriations" are appropriated to the agencies

1.23 and for the purposes specified in this article. The appropriations are from the general fund,

1.24 or another named fund, and are available for the fiscal years indicated for each purpose.

1.25 The figures "2022" and "2023" used in this article mean that the appropriations listed under

1.26 them are available for the fiscal year ending June 30, 2022, or June 30, 2023, respectively.

1.27 "The first year" is fiscal year 2022. "The second year" is fiscal year 2023. "The biennium"

1.28 is fiscal years 2022 and 2023. If an appropriation in this act is enacted more than once in

1.29 the 2022 legislative session, the appropriation must be given effect only once. Appropriations

2.1 for the fiscal year ending June 30, 2022, are effective the day following final enactment.
 2.2 The appropriations made under this article supplement, and do not supersede or replace,
 2.3 the appropriations made under Laws 2021, First Special Session chapter 4, article 1.

 4.23 Bureau, to conduct investigations, and to make arrests under sections 629.30 and 629.34.
 4.24 The primary jurisdiction of the law enforcement agency is limited to offenses ~~related to~~
 4.25 ~~insurance fraud~~ with a nexus to insurance-related crimes or financial crimes.

9.8 Commerce, at the expense of the applicant, in a qualified newspaper published in the
9.9 municipality in which the proposed industrial loan and thrift company is to be located, or,
9.10 if there be none, in a qualified newspaper likely to give notice in the municipality in which
9.11 the company is proposed to be located. If the Department of Commerce receives a written
9.12 objection to the application from any person within 15 days of the notice having been fully
9.13 published, the commissioner shall proceed in the same manner as required under section
9.14 46.041, subdivisions 3 and 4, relating to state banks.
