centralized activities will not necessarily evidence a nonunitary business. Unity is also
presumed when business activities or operations are of mutual benefit, dependent upon or
contributory to one another, either individually or as a group.

(h) Royalties and other income not qualifying for the deduction under section 10.1 290.0803 received for the use of or for the privilege of using intangible property, including 10.2 patents, know-how, formulas, designs, processes, patterns, copyrights, trade names, 10.3 service names, franchises, licenses, contracts, customer lists, or similar items, must be 10.4 attributed to the state in which the property is used by the purchaser. numerator and the denominator of the sales factor. Intangible property is used in this
state if the purchaser used the intangible property in the regular course of its business
operations in this state.

(j) Receipts from the performance of services must be attributed to the state where 10.19 10.20 the services are received. For the purposes of this section, receipts from the performance of services provided to a corporation, partnership, or trust may only be attributed to a state 10.21 where it has a fixed place of doing business. If the state where the services are received is 10.22 10.23 not readily determinable or is a state where the corporation, partnership, or trust receiving the service does not have a fixed place of doing business, the services shall be deemed 10.24 to be received at the location of the office of the customer from which the services were 10.25 ordered in the regular course of the customer's trade or business. - 11.8 Residence of other shareholders is the mailing address of the shareholder.

## 11.9 EFFECTIVE DATE. This section is effective for taxable years beginning after 11.10 December 31, 2013.
