(d) All uniforms, apparel, safety equipment, or protective accessories purchased or acquired under this section must be purchased from a manufacturer who is in compliance with the International Labor Organization's 1998 Declaration on Fundamental Principles and Rights at Work, regardless of that manufacturer's country of origin.
