1.5	Section 1. PEACE OFFICER EDUCATION REIMBURSEMENT.
1.6	(a) \$2,500,000 in fiscal year 2023 is appropriated from the general fund to the Board of
1.7	Peace Officer Standards and Training to provide education reimbursement grants to eligible
1.8	peace officers. Of this amount, up to 3.5 percent is for administration and monitoring of the
1.9	program.
1.10	(b) An eligible peace officer is a person who:
1.11	(1) is a peace officer as defined in Minnesota Statutes, section 626.84, subdivision 1,
1.12	paragraph (c);
1.13	(2) began employment as a peace officer on or after July 1, 2021;
1.14	(3) has been continuously employed as a peace officer for at least 12 months;
1.15	(4) has not been found to be in violation of the standards of conduct set forth in Minnesota
