1.2 relating to commerce; changing requirements for motor vehicle service contracts;

1.3 amending Minnesota Statutes 2016, section 59B.02, subdivision 11, by adding a

1.4 subdivision.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2016, section 59B.02, subdivision 11, is amended to read:

1.7 Subd. 11. **Service contract.** "Service contract" means a contract or agreement for a

1.8 separately stated consideration for a specific duration to perform:

1.9 (1) the repair, replacement, or maintenance of property or indemnification for repair,

1.10 replacement, or maintenance, for the operational or structural failure due to a defect in

1.11 materials, workmanship, or normal wear and tear, with or without additional provisions for

1.12 incidental payment of indemnity under limited circumstances, including without limitation,

1.13 towing, rental, emergency road service, and road hazard protection. Service contracts may

1.14 provide for the repair, replacement, or maintenance of property for damage resulting from

1.15 power surges and accidental damage from handling;

1.16 (2) the repair or replacement of tires or wheels on a motor vehicle damaged as result of

1.17 coming into contact with a road hazard;

1.18 (3) the removal of dents on a motor vehicle that can be repaired using the process of

1.19 paintless dent removal without affecting the existing paint finish or replacing vehicle body

1.20 panels, sanding, bonding, or painting;

1.21 (4) the repair of chips or cracks in a motor vehicle windshield or the replacement of a

1.22 motor vehicle windshield as a result of damage caused by a road hazard;

2.1 (5) the replacement of a motor vehicle key or key fob in the event that the key or key
2.2 fob becomes inoperable or is lost or stolen; or

2.3 (6) other services as approved by the commissioner.

2.6 Subd. 14. **Road hazard.** "Road hazard" means a danger encountered while driving a
2.7 motor vehicle including, but not limited to, potholes, rocks, weed debris, metal parts, glass,
2.8 plastic, curbs, or composite scraps.
