1.9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.10	Section 1. Minnesota Statutes 2014, section 201.014, is amended by adding a
1.11	subdivision to read:
1.12	Subd. 2a. Felony conviction; restoration of civil right to vote. An individual
1.13	convicted of a felony has the civil right to vote restored when the individual completes any
1.14	incarceration imposed and executed by the court for the offense, or upon sentencing if no
1.15	incarceration is imposed and executed. If the individual is later incarcerated for the same
1.16	offense, the individual's civil right to vote is lost only during the period of incarceration.

1.18	Subdivision 1. Form. Both paper and electronic voter registration applications must
1.19	contain the same information unless otherwise provided by law. A voter registration

2.21	The certification must include boxes for the voter to respond to the following

2.24	"(2) Will you be 18 years old on or before election day?"
2.25	And the instruction:
2.26	"If you checked 'no' to either of these questions, do not complete this form."
2.27	A paper voter registration application must be of suitable size and weight for
2.28	mailing. The form of the voter registration application and the certification of voter
2.29	eligibility must be as provided in this subdivision and approved by the secretary of state.
2.30	Voter registration forms authorized by the National Voter Registration Act must also be
2.31	accepted as valid. The federal postcard application form must also be accepted as valid if
2.32	it is not deficient and the voter is eligible to register in Minnesota.

[201.276] DUTIES OF SECRETARY OF STATE; INFORMATION 3.1 **ABOUT VOTING RIGHTS.** 3.2 The secretary of state shall develop accurate and complete information in a single 3.3 publication about the voting rights of people who have been charged with or convicted of 3.4 a crime. The secretary of state must make this publication available electronically to the 3.5 state court administrator for distribution to judges, court personnel, probation officers, 3.6 and the Department of Corrections for distribution to corrections officials, parole and 3.7 supervised release agents, and the public. The secretary of state must make the publication 3.8 available to the public on the Office of the Secretary of State's Web site. 3.9 Sec. 4. The county auditor shall prepare and provide to 3.11 each polling place sufficient copies of a poster setting forth the Voter's Bill of Rights as set 3.12 forth in this section. (3) If you can provide the required proof of residence, you have the right to register 3.23 to vote and to vote on election day. 3.24 3.25 (4) If you are unable to sign your name, you have the right to orally confirm your identity with an election judge and to direct another person to sign your name for you. 3.26 (5) You have the right to request special assistance when voting. 3.27 (6) If you need assistance, you may be accompanied into the voting booth by a 3.28 person of your choice, except by an agent of your employer or union or a candidate. 3.29 (7) You have the right to bring your minor children into the polling place and into 3.30 the voting booth with you. 3.31 (8) If you have been convicted of a felony but your felony sentence has expired 3.32 (been completed) or you have been discharged from your sentence, You have the right to 3.33 vote, even if you have been convicted of a felony, if you are not currently incarcerated for 3.34 the felony offense. 3.35

notice of filing an election contest.

"NOTICE OF RESTORATION OF YOUR RIGHT TO VOTE.

Your receipt of this notice today means that your right to vote in Minnesota has 5.23 been restored. Before you can vote on election day, you still need to register to vote. To 5.24 5.25 register, you may complete a voter registration application and return it to the Office of the Minnesota Secretary of State. You may also register to vote in your polling place on 5.26 election day. You will not be permitted to cast a ballot until you register to vote. The first 5.27 time you appear at your polling place to cast a ballot, you may be required to provide 5.28 proof of your current residence." 5.29 Subd. 4. Failure to provide notice. A failure to provide proper notice as required 5.30

APPENDIX Repealed Minnesota Statutes: 15-1551

201.275 INVESTIGATIONS; PROSECUTIONS.

(a) A law enforcement agency that is notified by affidavit of an alleged violation of this chapter shall promptly investigate. Upon receiving an affidavit alleging a violation of this chapter, a county attorney shall promptly forward it to a law enforcement agency with jurisdiction for investigation. If there is probable cause for instituting a prosecution, the county attorney shall proceed according to the generally applicable standards regarding the prosecutorial functions and duties of a county attorney, provided that the county attorney is not required to proceed with the prosecution if the complainant withdraws the allegation. A county attorney who refuses or intentionally fails to faithfully perform this or any other duty imposed by this chapter is guilty of a misdemeanor and upon conviction shall forfeit office.

(b) Willful violation of this chapter by any public employee constitutes just cause for suspension without pay or dismissal of the public employee.

(c) Where the matter relates to a voter registration application submitted electronically through the secure Web site established in section 201.061, subdivision 1, alleged violations of this chapter may be investigated and prosecuted in the county in which the individual registered or attempted to register.
