1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. Minnesota Statutes 2016, section 219.015, subdivision 1, is amended to read:
1.6	Subdivision 1. Positions Program established; inspector powers and duties. (a) The
1.7	commissioner of transportation shall must establish three a state rail safety inspector positions
1.8	in the Office of Freight and Commercial Vehicle Operations of the Minnesota Department
1.9	of Transportation. On or after July 1, 2015, the commissioner may establish a fourth state
1.10	rail safety inspector position following consultation with railroad companies inspection
1.11	program consisting of up to six positions, which may include state rail safety inspectors and
1.12	a program supervisor. The commissioner shall apply to and enter into agreements with the
1.13	Federal Railroad Administration (FRA) of the United States Department of Transportation

(c) A state rail safety inspector may perform, but is not limited to, the duties described 2.6 in the federal State Rail Safety Participation Program. An inspector may train, be certified, 2.7 and participate in any of the federal State Rail Safety Participation Program disciplines, 2.8 2.9 including: track, signal and train control, motive power and equipment, operating practices compliance, hazardous materials, and highway-rail grade crossings. 2.10

Subd. 2. Railroad company assessment; account; appropriation. (a) As provided in 2.16 2.17 this subdivision, the commissioner shall annually assess railroad companies that are (1) defined as common carriers under section 218.011; (2) classified by federal law or regulation 2.18 as Class I Railroads, Class I Rail Carriers, Class II Railroads, or Class II Carriers; and (3) 2.19 operating in this state. 2.20
