1.6	Section 1. [103F.05] MINNESOTA RIVER BASIN WATER QUALITY AND
1.7	STORAGE PROGRAM.
1.8	Subdivision 1. Definitions. For the purposes of this section:
1.9	(1) "board" means the Board of Water and Soil Resources; and
1.10	(2) "local units of government" has the meaning given under section 103B.305,
1.11	subdivision 5.
1.12	Subd. 2. Establishment. The board must establish a program to provide financial
1.13	assistance to local units of government located in the Minnesota River basin to control water
1.14	volume and rates for the purpose of protecting infrastructure and improving water quality
1.15	and related public benefits.
1.16	Subd. 3. Financial assistance. (a) The board may provide financial assistance to local
1.17	units of government to cover the costs of water storage projects and other water quality
1.18	practices consistent with a plan approved according to chapter 103B, 103C, or 103D. Costs
1.19	may include site acquisition, design, engineering, and construction. The board may acquire
1.20	conservation easements under sections 103F.501 to 103F.531 as necessary to implement a
1.21	project or practice under this section.

2.10	(b) When implementing the program, the board must:

2.12	(2) review and analyze projects and project sites; and

2.15	Resources Conservation Service of the United States Department of Agriculture, and other

2.17	Subd. 6. Requirements. (a) A local unit of government applying for financial assistance		
2.18	under this section must provide a copy of a resolution or other documentation of the local		
2.19	unit of government's support for the project. The documentation must include provisions		
2.20	for local funding and management, the proposed method of obtaining necessary land rights		
2.21	for the proposed project, and an assignment of responsibility for maintenance of any		
2.22	structures or practices upon completion of the project.		
2.23	(b) A local unit of government, with the assistance of the board, must evaluate the		
2.24	environmental and other benefits that are reasonably expected upon completion of the
