1.13 Section 1. Minnesota Statutes 2018, section 148.6402, subdivision 5, is amended to read:

1.14 Subd. 5. Contact hour. "Contact hour" means an instructional session of 60 consecutive
1.15 minutes, excluding coffee breaks, registration, meals without a speaker, and social activities.

1.16 Sec. 2. Minnesota Statutes 2018, section 148.6402, subdivision 21, is amended to read:

1.17 Subd. 21. Licensure by equivalency. "Licensure by equivalency" means a method of
1.18 licensure described in section 148.6412 by which an individual who possesses a current
1.19 credential from the National Board for Certification in Occupational Therapy may qualify
1.20 for licensure.

1.21 Sec. 3. Minnesota Statutes 2018, section 148.6403, subdivision 1, is amended to read:

1.22 Subdivision 1. Unlicensed practice prohibited. No A person shall must not engage in
1.23 the practice of occupational therapy unless the person is licensed as an occupational therapist

2.3 Sec. 4. Minnesota Statutes 2018, section 148.6403, subdivision 5, is amended to read:

2.4 Subd. 5. **Exempt persons.** This section does not apply to:

2.5 (1) a person employed as an ~~occupational therapist or occupational therapy assistant~~
2.6 practitioner by the government of the United States or any agency of it. However, use of
2.7 the protected titles under those circumstances is allowed only in connection with performance
2.8 of official duties for the federal government;

2.9 (2) a student participating in supervised fieldwork or supervised coursework that is
2.10 necessary to meet the requirements of section 148.6408, subdivision 1, or 148.6410,
2.11 subdivision 1, if the person is designated by a title which clearly indicates the person's status
2.12 as a student trainee. Any use of the protected titles under these circumstances is allowed
2.13 only while the person is performing the duties of the supervised fieldwork or supervised
2.14 coursework; or

2.15 (3) a person visiting and then leaving the state and performing occupational therapy

2.19 (i) the person is credentialed under the law of another state which has credentialing
2.20 requirements at least as stringent as the requirements of sections 148.6401 to 148.6449; or

2.22 registered (OTR) or a certified occupational therapy assistant (COTA), established by the
2.23 National Board for Certification in Occupational Therapy.

2.25 Subd. 6. **Sanctions.** A person who practices occupational therapy or holds out as an

2.27 of any title described in subdivision 2 without prior licensure according to sections 148.6401
2.28 to 148.6449 is subject to sanctions or action against continuing the activity according to
2.29 section 148.6448, chapter 214, or other statutory authority.

3.10 ~~administration and interpretation of standardized or nonstandardized tests and measurements,~~

4.5 (b) Occupational therapy services must be based on nationally established standards of
4.6 practice.

4.8 **148.6405 LICENSURE APPLICATION REQUIREMENTS: PROCEDURES AND**
4.9 **QUALIFICATIONS.**

4.10 (a) An applicant for licensure must comply with the application requirements in section
4.11 148.6420. To qualify for licensure, an applicant must satisfy one of the requirements in
4.12 paragraphs (b) to (f) and not be subject to denial of licensure under section 148.6448.

4.13 (b) A person who applies for licensure as an occupational therapist and who has not
4.14 been credentialed by the National Board for Certification in Occupational Therapy or another
4.15 jurisdiction must meet the requirements in section 148.6408.

4.16 (c) A person who applies for licensure as an occupational therapy assistant and who has
4.17 not been credentialed by the National Board for Certification in Occupational Therapy or
4.18 another jurisdiction must meet the requirements in section 148.6410.

4.19 (d) A person who is certified by the National Board for Certification in Occupational
4.20 Therapy may apply for licensure by equivalency and must meet the requirements in section
4.21 148.6412.

4.22 (e) A person who is credentialed in another jurisdiction and who was previously certified
4.23 by the National Board for Certification in Occupational Therapy may apply for licensure
4.24 by reciprocity and must meet the requirements in section 148.6415.

4.25 (f) A person who applies for temporary licensure must meet the requirements in section
4.26 148.6418.

4.27 (g) A person who applies for licensure under paragraph (b), (c), or (f) more than two
4.28 and less than four years after meeting the examination requirements in section 148.6408,
4.29 subdivision 2, or 148.6410, subdivision 2, must submit the following:

4.30 (1) a completed and signed application for licensure on forms provided by the board;

4.31 (2) the license application fee required under section 148.6445;

 5.28 Board for Certification in Occupational Therapy as an occupational therapist ~~after June 17,~~
 5.29 ~~1996,~~ if the board determines the requirements for certification are equivalent to or exceed
 5.30 the requirements for licensure as an occupational therapist under section 148.6408. The
 5.31 board may license any person certified by the National Board for Certification in
 5.32 Occupational Therapy as an occupational therapy assistant ~~after June 17, 1996,~~ if the board

6.6 A person who is not certified by the National Board for Certification in Occupational
6.7 Therapy but who holds a current credential as an occupational therapist in the District of
6.8 Columbia or a state or territory of the United States whose standards for credentialing are
6.9 determined by the board to be equivalent to or exceed the requirements for licensure under
6.10 section 148.6408 may be eligible for licensure by reciprocity as an occupational therapist.

6.11 A person who is not certified by the National Board for Certification in Occupational Therapy
6.12 but who holds a current credential as an occupational therapy assistant in the District of
6.13 Columbia or a state or territory of the United States whose standards for credentialing are
6.14 determined by the board to be equivalent to or exceed the requirements for licensure under
6.15 section 148.6410 may be eligible for licensure by reciprocity as an occupational therapy
6.16 assistant. Nothing in this section limits the board's authority to deny licensure based upon

6.20 (3) a copy of a current and unrestricted credential for the practice of occupational therapy
6.21 as either an occupational therapist or occupational therapy assistant;

6.22 (4) a letter from the jurisdiction that issued the credential describing the applicant's
6.23 qualifications that entitled the applicant to receive the credential; and

6.24 (5) other information necessary to determine whether the credentialing standards of the
6.25 jurisdiction that issued the credential are equivalent to or exceed the requirements for
6.26 licensure under sections 148.6401 to 148.6449.

6.27 Sec. 10. Minnesota Statutes 2018, section 148.6418, subdivision 4, is amended to read:

6.28 Subd. 4. **Supervision required.** An applicant who has graduated from an accredited
6.29 occupational therapy program, as required by section 148.6408, subdivision 1, or 148.6410,
6.30 subdivision 1, and who has not passed the examination required by section 148.6408,
6.31 subdivision 2, or 148.6410, subdivision 2, must practice under the supervision of a licensed
6.32 occupational therapist. The supervising therapist must, at a minimum, supervise the person

7.1 working under temporary licensure in the performance of the initial evaluation, determination
7.2 of the appropriate ~~treatment~~ intervention plan, and periodic review and modification of the
7.3 ~~treatment~~ intervention plan. The supervising therapist must observe the person working
7.4 under temporary licensure in order to ~~assure~~ ensure service competency in carrying out
7.5 evaluation, ~~treatment~~ intervention planning, and ~~treatment~~ intervention implementation.
7.6 The frequency of face-to-face collaboration between the person working under temporary
7.7 licensure and the supervising therapist must be based on the condition of each patient or
7.8 client, the complexity of ~~treatment~~ intervention and evaluation procedures, and the
7.9 proficiencies of the person practicing under temporary licensure. Following demonstrated
7.10 service competency of the applicant, supervision must occur no less than every ten
7.11 intervention days or every 30 calendar days, whichever occurs first. The occupational
7.12 therapist or occupational therapy assistant working under temporary licensure must provide
7.13 verification of supervision on the application form provided by the board.

7.15 **Subd. 5. Expiration of temporary licensure.** (a) A temporary license issued to a person
7.16 pursuant to subdivision 2, clause (1), must demonstrate to the board within the temporary
7.17 licensure period successful completion of the qualifying examination requirement under
7.18 section 148.6408, subdivision 2, or 148.6410, subdivision 2. A temporary license holder
7.19 who fails the qualifying examination for a second time shall have their temporary license
7.20 revoked effective upon notification to the temporary license holder of the examination score.
7.21 It is the temporary license holder's obligation to submit to the board their qualifying
7.22 examination scores and to refrain from practice if their temporary license is revoked. Failure

9.9 Subd. 4. **Applicants credentialed in another jurisdiction.** In addition to providing the
9.10 materials required in subdivision 1, an applicant credentialed in another jurisdiction must
9.11 request that the appropriate government body in each jurisdiction in which the applicant
9.12 holds or held an occupational therapy credential ~~send a letter to the commissioner~~ provide
9.13 documentation to the board that verifies the applicant's credentials. Except as provided in
9.14 section 148.6418, a license ~~shall~~ must not be issued until the ~~commissioner~~ board receives
9.15 ~~letters verifying~~ verification of each of the applicant's credentials. Each ~~letter~~ verification

9.24 (b) The board shall determine if the applicant meets the requirements for licensure. The
9.25 board, ~~or the advisory council at the board's request,~~ may investigate information provided
9.26 by an applicant to determine whether the information is accurate and complete.

9.27 (c) The board shall notify an applicant of action taken on the application and, if licensure
9.28 is denied or approved with conditions, the grounds for the board's determination.

9.29 (d) An applicant denied licensure or granted licensure with conditions may make a
9.30 written request to the board, within 30 days of the date of the board's determination, for

10.8 Subdivision 1. **Renewal requirements.** To be eligible for licensure renewal, a licensee
10.9 must:

10.10 (1) submit a completed and signed application for licensure renewal ~~on forms provided~~
10.11 ~~by the board;~~

10.12 (2) submit the renewal fee required under section 148.6445;

10.13 (3) submit proof of having met the continuing education requirement of section 148.6443
10.14 ~~on forms provided by the board;~~ and

10.15 (4) submit additional information as requested by the board to clarify information
10.16 presented in the renewal application. The information must be submitted within 30 calendar
10.17 days after of the board's request.

10.18 Subd. 2. **Renewal deadline.** (a) Except as provided in paragraph (c), licenses must be

10.21 (b) Each license must state an expiration date. An application for licensure renewal must
10.22 be received by the board ~~or postmarked~~ at least 30 calendar days before the expiration date.

10.25 (c) If the board changes the renewal schedule and the expiration date is less than two
10.26 years, the fee and the continuing education contact hours to be reported at the next renewal
10.27 must be prorated.

10.28 (d) An application for licensure renewal not received within the time required under
10.29 paragraph (b), but received on or before the expiration date, must be accompanied by a late
10.30 fee in addition to the renewal fee specified by section 148.6445.

10.31 (e) Licensure renewals received after the expiration date ~~shall not be accepted and persons~~
10.32 ~~seeking licensed status~~ must comply with the requirements of section 148.6425.

11.1 Subd. 3. **Licensure renewal notice.** At least 60 ~~calendar~~ days before the expiration date
11.2 in subdivision 2, the board ~~shall mail~~ must send or transmit a renewal notice to the licensee's
11.3 ~~last known address on file with the board~~ licensee. The notice must include ~~an application~~
11.4 ~~for licensure renewal and notice of fees required for renewal~~ information about accessing
11.5 the license renewal and fee schedule. The licensee's failure to receive notice does not relieve
11.6 the licensee of the obligation to meet the renewal deadline and other requirements for
11.7 licensure renewal.

11.8 Subd. 4. **License renewal cycle conversion.** The license renewal cycle for occupational
11.9 therapy licensees is converted to a two-year cycle where renewal is due on the last day of
11.10 the licensee's month of birth. Conversion pursuant to this section begins January 1, 2021.
11.11 This section governs license renewal procedures for licensees who were licensed before
11.12 December 31, 2020. The conversion renewal cycle is the renewal cycle following the first
11.13 license renewal after January 1, 2020. The conversion license period is the license period
11.14 for the conversion renewal cycle. The conversion license period is between 13 and 24 months
11.15 and ends on the last day of the licensee's month of birth in either 2022 or 2023, as described
11.16 in subdivision 5.

11.17 Subd. 5. **Conversion of license renewal cycle for current licensees.** For a licensee
11.18 whose license is current as of December 31, 2020, the licensee's conversion license period
11.19 begins on January 1, 2021, and ends on the last day of the licensee's month of birth in 2023,
11.20 except that for licensees whose month of birth is January, February, March, April, May, or
11.21 June, the licensee's renewal cycle ends on the last day of the licensee's month of birth in
11.22 2022.

11.23 Subd. 6. **Conversion of license renewal cycle for noncurrent licensees.** This subdivision
11.24 applies to a licensee who was licensed before December 31, 2020, but whose license is not
11.25 current as of December 31, 2020. When the licensee first renews the license after January
11.26 1, 2021, the conversion renewal cycle begins on the date the licensee applies for renewal
11.27 and ends on the last day of the licensee's month of birth in the next year, except that if the

148.6402 DEFINITIONS.

Subd. 10. **Direct supervision.** "Direct supervision" of an occupational therapy assistant using physical agent modalities means that the occupational therapist has evaluated the patient and determined a need for use of a particular physical agent modality in the occupational therapy treatment plan, has determined the appropriate physical agent modality application procedure, and is available for in-person intervention while treatment is provided.

Subd. 15. **Occupational therapy.** "Occupational therapy" means the use of purposeful activity to maximize the independence and the maintenance of health of an individual who is limited by a physical injury or illness, a cognitive impairment, a psychosocial dysfunction, a mental illness, a developmental or learning disability, or an adverse environmental condition. The practice encompasses evaluation, assessment, treatment, and consultation. Occupational therapy services may be provided individually, in groups, or through social systems. Occupational therapy includes those services described in section 148.6404.

148.6412 LICENSURE BY EQUIVALENCY.

Subdivision 1. **Persons certified by National Board for Certification in Occupational Therapy before June 17, 1996.** Persons certified by the National Board for Certification in Occupational Therapy as an occupational therapist before June 17, 1996, may apply for licensure by equivalency for occupational therapist. Persons certified by the National Board for Certification in Occupational Therapy as an occupational therapy assistant before June 17, 1996, may apply for licensure by equivalency for occupational therapy assistant.

Subp. 28. **Occupational therapy.** "Occupational therapy" has the meaning given in Minnesota Statutes, section 148.6402, subdivision 15.
