1.8	Section 1. [604.135] CRITICAL INFRASTRUCTURE; VICARIOUS LIABILITY.
1.9	(a) A person who is arrested for or convicted of trespass under section 609.6055 or
1.10	609.595 may be held liable for any damages to personal or real property while trespassing.
1.11	(b) A person or entity that recruits, trains, aids, advises, hires, counsels, or conspires
1.12	with or otherwise procures another to trespass as described in paragraph (a) may also be
1.13	held vicariously liable for any damages to personal or real property committed by the
1.14	individual arrested or convicted under section 609.6055 or 609.595.
1.15	EFFECTIVE DATE. This section is effective on August 1, 2018, and applies to causes
1.16	of action brought on or after that date.

- (b) Whoever intentionally recruits, trains, aids, advises, hires, counsels, or conspires with or otherwise procures another to commit a violation of paragraph (a) is guilty of a felony and may be sentenced to imprisonment for not more than ten years or to payment of a fine of not more than \$20,000, or both, if a violation is committed and the person fails to make a reasonable effort to prevent the violation. EFFECTIVE DATE. This section is effective August 1, 2018, and applies to violations committed on or after that date. Sec. 3.
