1.9	Section 1. Minnesota Statutes 2022, section 144.555, subdivision 1a, is amended to read
1.10	Subd. 1a. Notice of closing, curtailing operations, relocating services, or ceasing to
1.11	offer certain services; hospitals. (a) The controlling persons of a hospital licensed under
1.12	sections 144.50 to 144.56 or a hospital campus must notify the commissioner of health and
1.13	the public, and others at least 120 300 days before the hospital or hospital campus voluntarily
1.14	plans to implement one of the following scheduled actions:
1.15	(1) cease operations;
1.16	(2) curtail operations to the extent that patients must be relocated;
1.17	(3) relocate the provision of health services to another hospital or another hospital
1.18	campus; or
1.19	(4) cease offering maternity care and newborn care services, intensive care unit services

Subd. 1b. **Public hearing.** Within 45 30 days after receiving notice under subdivision 1a, the commissioner shall conduct a public hearing on the scheduled cessation of operations, curtailment of operations, relocation of health services, or cessation in offering health services. The commissioner must provide adequate public notice of the hearing in a time and manner determined by the commissioner. The controlling persons of the hospital or hospital campus must participate in the public hearing. The public hearing must be held at a location that is within ten miles of the hospital or hospital campus and that is provided or arranged by the hospital or hospital campus. Video conferencing technology must be used to allow members of the public to view and participate in the hearing. The public hearing must include:

- (1) an explanation by the controlling persons of the reasons for ceasing or curtailing operations, relocating health services, or ceasing to offer any of the listed health services;
- (2) a description of the actions that controlling persons will take to ensure that residents in the hospital's or campus's service area have continued access to the health services being eliminated, curtailed, or relocated;
- (3) an opportunity for public testimony on the scheduled cessation or curtailment of operations, relocation of health services, or cessation in offering any of the listed health services, and on the hospital's or campus's plan to ensure continued access to those health services being eliminated, curtailed, or relocated; and
- (4) an opportunity for the controlling persons to respond to questions from interested persons.

 subdivision 1a must be provided to patients, hospital personnel, the public, local officials,

 health services, or cessation in offering health services at the main public entrance of the
 hospital or hospital campus;
