1.5	Section 1. FAMILY, FRIEND, AND NEIGHBOR GRANT PROGRAM.
1.6	Subdivision 1. Establishment. A family, friend, and neighbor (FFN) grant program is
1.7	established to promote children's social emotional learning and healthy development, early
1.8	literacy, and school readiness, and to foster community partnerships to promote children's
1.9	school readiness. The commissioner of health must make grants available to fund:
1.10	(1) community health boards, local or regional libraries, community-based organizations,
1.11	nonprofit organizations, and Indian tribes working with FFN caregivers under subdivision
