1.1 A bill for an act
1.2 relating to housing; modifying the Minnesota Bond Allocation Act related to
1.3 housing bonds; amending Minnesota Statutes 2016, sections 474A.02, by adding
1.4 subdivisions; 474A.03, subdivision 1; 474A.04, subdivision 1a; 474A.061,
1.5 subdivisions 1, 2a, 2b, 2c, 4, by adding subdivisions; 474A.062; 474A.091,
1.6 subdivisions 1, 2, 3, 5, by adding a subdivision; 474A.131, subdivisions 1, 1b, 2;
1.7 474A.14.

1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.9 Section 1. Minnesota Statutes 2016, section 474A.02, is amended by adding a subdivision
1.10 to read:

1.11 Subd. 30. Preservation project. "Preservation project" means any residential rental
1.12 project, regardless of whether or not the project is restricted to persons of a certain age or
1.13 older that receive federal project-based rental subsidies. In addition, to qualify as a
1.14 preservation project, the amount of bonds requested in the application must not exceed the
1.15 aggregate bond limitation.

1.16 Sec. 2. Minnesota Statutes 2016, section 474A.02, is amended by adding a subdivision to
1.17 read:

1.18 Subd. 31. 30 percent AMI residential rental project. "30 percent AMI residential
1.19 rental project" means a residential rental project that does not otherwise qualify as a
1.20 preservation project, is expected to generate low-income housing tax credits under section
1.21 42 of the Internal Revenue Code from 100 percent of its residential units, and: (1) in which
1.22 all the residential units of the project: (i) are reserved for tenants whose income, on average
1.23 is 30 percent of AMI or less; (ii) are rent restricted in accordance with section 42(g)(2) of
1.24 the Internal Revenue Code; and (iii) are subject to the rent and income restrictions for a

2.1 period of not less than 30 years; or (2)(i) is located within a county or metropolitan area
 2.2 that has a current area median gross income that is less than the statewide area median
 2.3 income for the state of Minnesota; (ii) all of the units of the project are rent restricted in
 2.4 accordance with section 42(g)(2) of the Internal Revenue Code; and (iii) all of the units of
 2.5 the project are subject to the applicable rent and income restrictions for a period of not less
 2.6 than 30 years. In addition, to qualify as a 30 percent AMI residential rental project, the
 2.7 amount of bonds requested in the application must not exceed the aggregate bond limitation.
 2.8 For purposes of this subdivision, "on average" means the average of the applicable income
 2.9 limitation level for a project determined on a unit-by-unit basis e.g., a project with one-half
 2.10 of its units subject to income limitations of not greater than 20 percent AMI and one-half
 2.11 subject to income limitations of not greater than 40 percent AMI would be subject to an
 2.12 income limitation on average of not greater than 30 percent AMI.

2.13 Sec. 3. Minnesota Statutes 2016, section 474A.02, is amended by adding a subdivision to
 2.14 read:

2.15 Subd. 32. **50 percent AMI residential rental project.** "50 percent AMI residential
 2.16 rental project" means a residential rental project that does not qualify as a preservation
 2.17 project or a 30 percent AMI residential rental project, is expected to generate low-income
 2.18 housing tax credits under section 42 of the Internal Revenue Code from 100 percent of its
 2.19 residential units, and in which all the residential units of the project: (1) are reserved for
 2.20 tenants whose income on average is 50 percent of AMI or less; (2) are rent restricted in
 2.21 accordance with section 42(g)(2) of the Internal Revenue Code; and (3) are subject to the
 2.22 rent and income restrictions for a period of not less than 30 years. In addition, to qualify as
 2.23 a 50 percent AMI residential rental project, the amount of bonds requested in the application
 2.24 must not exceed the aggregate bond limitation. For purposes of this subdivision, "on average"
 2.25 means the average of the applicable income limitation level for a project determined on a
 2.26 unit-by-unit basis e.g., a project with one-half of its units subject to income limitations of
 2.27 not greater than 40 percent AMI and one-half subject to income limitations of not greater
 2.28 than 60 percent AMI would be subject to an income limitation on average of not greater
 2.29 than 50 percent AMI.

2.30 Sec. 4. Minnesota Statutes 2016, section 474A.02, is amended by adding a subdivision to
 2.31 read:

2.32 Subd. 33. **100 percent LIHTC project.** "100 percent LIHTC project" means a residential
 2.33 rental project that is expected to generate low-income housing tax credits under section 42
 2.34 of the Internal Revenue Code from 100 percent of its residential units and does not otherwise

3.1 qualify as a preservation project, a 30 percent AMI residential rental project, or a 50 percent
3.2 AMI residential rental project. In addition, to qualify as a 100 percent LIHTC project, the
3.3 amount of bonds requested in the application must not exceed the aggregate bond limitation.

3.4 Sec. 5. Minnesota Statutes 2016, section 474A.02, is amended by adding a subdivision to
3.5 read:

3.6 Subd. 34. **20 percent LIHTC project.** "20 percent LIHTC project" means a residential
3.7 rental project that is expected to generate low-income housing tax credits under section 42
3.8 of the Internal Revenue Code from at least 20 percent of its residential units and does not
3.9 otherwise qualify as a preservation project, a 30 percent AMI residential rental project, a
3.10 50 percent AMI residential rental project, or a 100 percent LIHTC project. In addition, to
3.11 qualify as a 20 percent LIHTC project, the amount of bonds requested in the application
3.12 must not exceed the aggregate bond limitation.

3.13 Sec. 6. Minnesota Statutes 2016, section 474A.02, is amended by adding a subdivision to
3.14 read:

3.15 Subd. 35. **AMI.** "AMI" means the area median income for the applicable county or
3.16 metropolitan area as published by the Department of Housing and Urban Development, as
3.17 adjusted for household size.

3.18 Sec. 7. Minnesota Statutes 2016, section 474A.02, is amended by adding a subdivision to
3.19 read:

3.20 Subd. 36. **Aggregate bond limitation.** "Aggregate bond limitation" means up to 55
3.21 percent of the reasonably expected aggregate basis of a residential rental project and the
3.22 land on which the project is or will be located.

3.23 Sec. 8. Minnesota Statutes 2016, section 474A.03, subdivision 1, is amended to read:

3.24 Subdivision 1. **Under federal tax law; allocations.** At the beginning of each calendar
3.25 year after December 31, 2001, the commissioner shall determine the aggregate dollar amount
3.26 of the annual volume cap under federal tax law for the calendar year, and of this amount
3.27 the commissioner shall make the following allocation:

3.28 (1) \$74,530,000 to the small issue pool;

3.29 (2) \$122,060,000 to the housing pool, of which 31 percent of the adjusted allocation is
3.30 reserved until the last Monday in ~~July~~ June for single-family housing programs;

4.1 (3) \$12,750,000 to the public facilities pool; and

4.2 (4) amounts to be allocated as provided in subdivision 2a.

4.3 If the annual volume cap is greater or less than the amount of bonding authority allocated
4.4 under clauses (1) to (4) and subdivision 2a, paragraph (a), clauses (1) to (4), the allocation
4.5 must be adjusted so that each adjusted allocation is the same percentage of the annual volume
4.6 cap as each original allocation is of the total bonding authority originally allocated.

4.7 Sec. 9. Minnesota Statutes 2016, section 474A.04, subdivision 1a, is amended to read:

4.8 Subd. 1a. **Entitlement reservations.** Any amount returned by an entitlement issuer
4.9 before July ~~15~~ 1 shall be reallocated through the housing pool. Any amount returned on or
4.10 after July ~~15~~ 1 shall be reallocated through the unified pool. An amount returned after the
4.11 last Monday in November shall be reallocated to the Minnesota Housing Finance Agency.

4.12 Sec. 10. Minnesota Statutes 2016, section 474A.061, subdivision 1, is amended to read:

4.13 Subdivision 1. **Allocation application; small issue pool and public facilities pool.** (a)
4.14 For any requested allocations from the small issue pool or the public facilities pool, an issuer
4.15 may apply for an allocation under this section by submitting to the department an application
4.16 on forms provided by the department, accompanied by (1) a preliminary resolution, (2) a
4.17 statement of bond counsel that the proposed issue of obligations requires an allocation under
4.18 this chapter and the Internal Revenue Code, (3) the type of qualified bonds to be issued, (4)
4.19 an application deposit in the amount of one percent of the requested allocation before the
4.20 last Monday in ~~July~~ June, or in the amount of two percent of the requested allocation on or
4.21 after the last Monday in ~~July~~, June; and (5) a public purpose scoring worksheet for
4.22 manufacturing project and enterprise zone facility project applications, ~~and (6) for residential~~

4.26 must pay the application deposit by a check made payable to the Department of Management

4.28 Authority, and the Minnesota Office of Higher Education may apply for and receive an
4.29 allocation under this section without submitting an application deposit.

4.30 (b) An entitlement issuer may not apply for an allocation ~~from the public facilities pool~~
4.31 under this subdivision unless it has either permanently issued bonds equal to the amount of
4.32 its entitlement allocation for the current year plus any amount of bonding authority carried
4.33 forward from previous years or returned for reallocation all of its unused entitlement

5.11 (c) If an application is rejected under this section, the commissioner must notify the
 5.12 applicant and return the application deposit to the applicant within 30 days unless the

 5.14 of bonding authority under this section must be evidenced by a certificate of allocation.

5.15 Sec. 11. Minnesota Statutes 2016, section 474A.061, is amended by adding a subdivision
 5.16 to read:

5.17 Subd. 1a. **Allocation application; housing pool.** (a) For any requested allocations from
 5.18 the housing pool, an issuer may apply for an allocation under this section by submitting to
 5.19 the department an application on forms provided by the department, accompanied by: (1)
 5.20 a preliminary resolution; (2) a statement of bond counsel that the proposed issue of
 5.21 obligations requires an allocation under this chapter and the Internal Revenue Code; (3) an
 5.22 application deposit in the amount of two percent of the requested allocation; (4) a sworn
 5.23 statement from the applicant identifying the project as either a preservation project, a 30
 5.24 percent AMI residential rental project, a 50 percent AMI residential rental project, a 100
 5.25 percent LIHTC project, a 20 percent LIHTC project, or any other residential rental project;
 5.26 and (5) a certification from the applicant or the applicant's accountant stating whether the
 5.27 requested allocation exceeds the aggregate bond limitation. The issuer must pay the
 5.28 application deposit by a check made payable to the Department of Management and Budget.
 5.29 The Minnesota Housing Finance Agency may apply for and receive an allocation under this
 5.30 section without submitting an application deposit.

5.31 (b) An entitlement issuer may not apply for an allocation from the housing pool unless
 5.32 it has either permanently issued bonds equal to any amount of bonding authority carried
 5.33 forward from a previous year or returned for reallocation any unused bonding authority
 5.34 carried forward from a previous year. For purposes of this subdivision, an entitlement

6.1 allocation includes an amount obtained under section 474A.04, subdivision 6. This paragraph
 6.2 does not apply to an application from the Minnesota Housing Finance Agency for an
 6.3 allocation under subdivision 2a for cities that choose to have the agency issue bonds on
 6.4 their behalf.

6.5 (c) If an application is rejected under this section, the commissioner must notify the
 6.6 applicant and return the application deposit to the applicant within 30 days unless the
 6.7 applicant requests in writing that the application be resubmitted. The granting of an allocation
 6.8 of bonding authority under this section must be evidenced by a certificate of allocation.

6.9 Sec. 12. Minnesota Statutes 2016, section 474A.061, subdivision 2a, is amended to read:

6.10 Subd. 2a. **Housing pool allocation.** (a) Commencing on the second Tuesday in January
 6.11 and continuing on each Monday through ~~July 15~~ the end of June, the commissioner shall
 6.12 allocate available bonding authority from the housing pool to applications received on or
 6.13 before the Monday of the preceding week for residential rental projects that meet the
 6.14 eligibility criteria under section 474A.047. Allocations of available bonding authority from
 6.15 the housing pool for eligible residential rental projects shall be awarded in the following
 6.16 order of priority: (1) ~~projects that preserve existing federally subsidized housing; (2) projects~~
 6.17 ~~that are not restricted to persons who are 55 years of age or older; and preservation projects;~~
 6.18 (2) 30 percent AMI residential rental projects; (3) 50 percent AMI residential rental projects;
 6.19 (4) 100 percent LIHTC projects; (5) 20 percent LIHTC projects; and (6) other residential
 6.20 rental projects. Prior to May 15, no allocation shall be made to a project restricted to persons
 6.21 who are 55 years of age or older. If an If there are two or more applications for residential
 6.22 rental projects at the same priority level and there is insufficient bonding authority to provide
 6.23 allocations for all the projects in any one allocation period, available bonding authority shall
 6.24 be randomly awarded by lot but only for projects that can receive the full amount of their
 6.25 respective requested allocations. If a residential rental project does not receive any of its
 6.26 requested allocation pursuant to this paragraph and the project applies in the future to the
 6.27 housing pool or unified pool for additional allocation of bonds, the project shall be fully
 6.28 funded up to its original application request for bonding authority before any new project,
 6.29 applying in the same allocation period, that has an equal priority shall receive bonding
 6.30 authority. An issuer that receives an allocation under this paragraph does not issue obligations
 6.31 equal to all or a portion of the allocation received within 120 days of the allocation must
 6.32 issue obligations equal to all or a portion of the allocation received on or before the later of
 6.33 180 days of the allocation or within 18 months after the allocation date if the applicant
 6.34 submits an additional application deposit equal to one percent of the allocation amount on
 6.35 or prior to 180 days after the allocation date. If an issuer that receives an allocation under

7.1 this paragraph does not issue obligations equal to all or a portion of the allocation received
7.2 within the time period provided in this paragraph or returns the allocation to the
7.3 commissioner, the amount of the allocation is canceled and returned for reallocation through
7.4 the housing pool or to the unified pool after July 15, 1. If an issuer that receives an allocation
7.5 under this paragraph issues obligations within the time period provided in this paragraph,
7.6 the commissioner shall refund 50 percent of any application deposit previously paid within
7.7 30 days of the issuance of the obligations and the remaining 50 percent of the application
7.8 deposit within 30 days after completion of construction of the project.

7.9 (b) After January 1, and through January 15, the Minnesota Housing Finance Agency
7.10 may accept applications from cities for single-family housing programs which meet program
7.11 requirements as follows:

7.12 (1) the housing program must meet a locally identified housing need and be economically
7.13 viable;

7.14 (2) the adjusted income of home buyers may not exceed 80 percent of the greater of
7.15 ~~statewide or area median income as published by the Department of Housing and Urban~~
7.16 ~~Development, adjusted for household size~~ AMI;

7.17 (3) house price limits may not exceed the federal price limits established for mortgage
7.18 revenue bond programs. Data on the home purchase price amount, mortgage amount, income,
7.19 household size, and race of the households served in the previous year's single-family
7.20 housing program, if any, must be included in each application; and

7.21 (4) for applicants who choose to have the agency issue bonds on their behalf, an
7.22 application fee pursuant to section 474A.03, subdivision 4, and an application deposit equal
7.23 to one percent of the requested allocation must be submitted to the Minnesota Housing
7.24 Finance Agency before the agency forwards the list specifying the amounts allocated to the
7.25 commissioner under paragraph (d). The agency shall submit the city's application fee and
7.26 application deposit to the commissioner when requesting an allocation from the housing
7.27 pool.

7.28 Applications by a consortium shall include the name of each member of the consortium
7.29 and the amount of allocation requested by each member.

7.30 (c) Any amounts remaining in the housing pool after July 15, 1 are available for
7.31 single-family housing programs for cities that applied in January and received an allocation
7.32 under this section in the same calendar year. For a city that chooses to issue bonds on its
7.33 own behalf or pursuant to a joint powers agreement, the agency must allot available bonding
7.34 authority based on the formula in paragraphs (d) and (f). Allocations will be made loan by

8.1 loan, on a first-come, first-served basis among cities on whose behalf the Minnesota Housing
8.2 Finance Agency issues bonds.

8.3 Any city that received an allocation pursuant to paragraph (f) in the same calendar year
8.4 that wishes to issue bonds on its own behalf or pursuant to a joint powers agreement for an
8.5 amount becoming available for single-family housing programs after July ~~15~~ 1 shall notify
8.6 the Minnesota Housing Finance Agency by July ~~15~~ 1. The Minnesota Housing Finance
8.7 Agency shall notify each city making a request of the amount of its allocation within three
8.8 business days after July ~~15~~ 1. The city must comply with paragraph (f).

8.9 For purposes of paragraphs (a) to (h), "city" means a county or a consortium of local
8.10 government units that agree through a joint powers agreement to apply together for
8.11 single-family housing programs, and has the meaning given it in section 462C.02, subdivision
8.12 6. "Agency" means the Minnesota Housing Finance Agency.

8.13 (d) The total amount of allocation for mortgage bonds for one city is limited to the lesser
8.14 of: (i) the amount requested, or (ii) the product of the total amount available for mortgage
8.15 bonds from the housing pool, multiplied by the ratio of each applicant's population as
8.16 determined by the most recent estimate of the city's population released by the state
8.17 demographer's office to the total of all the applicants' population, except that each applicant
8.18 shall be allocated a minimum of \$100,000 regardless of the amount requested or the amount
8.19 determined under the formula in clause (ii). If a city applying for an allocation is located
8.20 within a county that has also applied for an allocation, the city's population will be deducted
8.21 from the county's population in calculating the amount of allocations under this paragraph.

8.22 Upon determining the amount of each applicant's allocation, the agency shall forward
8.23 to the commissioner a list specifying the amounts allotted to each application with all
8.24 application fees and deposits from applicants who choose to have the agency issue bonds
8.25 on their behalf.

8.26 Total allocations from the housing pool for single-family housing programs may not
8.27 exceed 31 percent of the adjusted allocation to the housing pool until after July ~~15~~ 1.

8.28 (e) The agency may issue bonds on behalf of participating cities. The agency shall request
8.29 an allocation from the commissioner for all applicants who choose to have the agency issue
8.30 bonds on their behalf and the commissioner shall allocate the requested amount to the
8.31 agency. The agency may request an allocation at any time after the second Tuesday in
8.32 January and through the last Monday in ~~July~~ June. After awarding an allocation and receiving
8.33 a notice of issuance for the mortgage bonds issued on behalf of the participating cities, the
8.34 commissioner shall transfer the application deposits to the Minnesota Housing Finance

9.1 Agency to be returned to the participating cities. The Minnesota Housing Finance Agency
9.2 shall return any application deposit to a city that paid an application deposit under paragraph
9.3 (b), clause (4), but was not part of the list forwarded to the commissioner under paragraph
9.4 (d).

9.5 (f) A city may choose to issue bonds on its own behalf or through a joint powers
9.6 agreement and may request an allocation from the commissioner by forwarding an application
9.7 with an application fee pursuant to section 474A.03, subdivision 4, and a one percent
9.8 application deposit to the commissioner no later than the Monday of the week preceding
9.9 an allocation. If the total amount requested by all applicants exceeds the amount available
9.10 in the pool, the city may not receive a greater allocation than the amount it would have
9.11 received under the list forwarded by the Minnesota Housing Finance Agency to the
9.12 commissioner. No city may request or receive an allocation from the commissioner until
9.13 the list under paragraph (d) has been forwarded to the commissioner. A city must request
9.14 an allocation from the commissioner no later than the last Monday in ~~July~~ June. No city
9.15 may receive an allocation from the housing pool for mortgage bonds which has not first
9.16 applied to the Minnesota Housing Finance Agency. The commissioner shall allocate the
9.17 requested amount to the city or cities subject to the limitations under this paragraph.

9.18 If a city issues mortgage bonds from an allocation received under this paragraph, the
9.19 issuer must provide for the recycling of funds into new loans. If the issuer is not able to
9.20 provide for recycling, the issuer must notify the commissioner in writing of the reason that
9.21 recycling was not possible and the reason the issuer elected not to have the Minnesota
9.22 Housing Finance Agency issue the bonds. "Recycling" means the use of money generated
9.23 from the repayment and prepayment of loans for further eligible loans or for the redemption
9.24 of bonds and the issuance of current refunding bonds.

9.25 (g) No entitlement city or county or city in an entitlement county may apply for or be
9.26 allocated authority to issue mortgage bonds or use mortgage credit certificates from the
9.27 housing pool. No city in an entitlement county may apply for or be allocated authority to
9.28 issue residential rental bonds from the housing pool or the unified pool.

9.29 (h) A city that does not use at least 50 percent of its allotment by the date applications
9.30 are due for the first allocation that is made from the housing pool for single-family housing
9.31 programs in the immediately succeeding calendar year may not apply to the housing pool
9.32 for a single-family mortgage bond or mortgage credit certificate program allocation that
9.33 exceeds the amount of its allotment for the preceding year that was used by the city in the
9.34 immediately preceding year or receive an allotment from the housing pool in the succeeding
9.35 calendar year that exceeds the amount of its allotment for the preceding year that was used

10.1 in the preceding year. The minimum allotment is \$100,000 for an allocation made prior to
10.2 ~~July 15~~ 1, regardless of the amount used in the preceding calendar year, except that a city
10.3 whose allocation in the preceding year was the minimum amount of \$100,000 and who did
10.4 not use at least 50 percent of its allocation from the preceding year is ineligible for an
10.5 allocation in the immediate succeeding calendar year. Each local government unit in a
10.6 consortium must meet the requirements of this paragraph.

10.7 Sec. 13. Minnesota Statutes 2016, section 474A.061, subdivision 2b, is amended to read:

10.8 Subd. 2b. **Small issue pool allocation.** Commencing on the second Tuesday in January
10.9 and continuing on each Monday through the last Monday in ~~July~~ June, the commissioner
10.10 shall allocate available bonding authority from the small issue pool to applications received
10.11 on or before the Monday of the preceding week for manufacturing projects and enterprise
10.12 zone facility projects. From the second Tuesday in January through the last Monday in ~~July~~
10.13 June, the commissioner shall reserve \$5,000,000 of the available bonding authority from
10.14 the small issue pool for applications for agricultural development bond loan projects of the
10.15 Minnesota Rural Finance Authority.

10.16 Beginning in calendar year 2002, on the second Tuesday in January through the last
10.17 Monday in ~~July~~ June, the commissioner shall reserve \$10,000,000 of available bonding
10.18 authority in the small issue pool for applications for student loan bonds of or on behalf of
10.19 the Minnesota Office of Higher Education. The total amount of allocations for student loan
10.20 bonds from the small issue pool may not exceed \$10,000,000 per year.

10.21 The commissioner shall reserve \$10,000,000 until the day after the last Monday in
10.22 February, \$10,000,000 until the day after the last Monday in April, and \$10,000,000 until
10.23 the day after the last Monday in June in the small issue pool for enterprise zone facility
10.24 projects and manufacturing projects. The amount of allocation provided to an issuer for a
10.25 specific enterprise zone facility project or manufacturing project will be based on the number
10.26 of points received for the proposed project under the scoring system under section 474A.045.

10.27 If there are two or more applications for manufacturing and enterprise zone facility
10.28 projects from the small issue pool and there is insufficient bonding authority to provide
10.29 allocations for all projects in any one week, the available bonding authority shall be awarded
10.30 based on the number of points awarded a project under section 474A.045, with those projects
10.31 receiving the greatest number of points receiving allocation first. If two or more applications
