1.7	Section 1. [126C.90] COMPREHENSIVE SUPPORT FOR SCHOOLS IN NEED.
1.8	Subdivision 1. Qualifying site. An elementary school site identified as in need of
1.9	comprehensive support under Minnesota's plan implementing the Every Student Succeeds
1.10	Act must meet the requirements of this section to be eligible for additional state aid according
1.11	to this section. A site remains qualified under this section for seven years.
1.12	Subd. 2. Site-based revenue. The Department of Education must develop a site-based
1.13	revenue model for each school district with an elementary school identified as a qualifying
1.14	site under subdivision 1. A school district must report data in the form and manner required
1.15	by the commissioner. The department may allocate expenditures that are not site specific
1.16	to each site on a proportionate basis.
1.17	Subd. 3. Site-based revenue allocated to school sites. A school district must allocate
1.18	all additional aid received under this section to the site identified as a qualifying school site
