## 1.12 Section 1. [17.1195] FARM SAFETY GRANT AND OUTREACH PROGRAMS.

#### 1.13 Subdivision 1. Tractor rollover grants. (a) The commissioner may award grants to

- 1.14 Minnesota farmers and Minnesota schools that retrofit eligible tractors with eligible rollover
- 1.15 protective structures.

#### 1.16 (b) Grants for farmers are limited to 70 percent of the farmer's documented cost to

- 1.17 purchase, ship, and install an eligible rollover protective structure. The commissioner must
- 1.18 increase a farmer's grant award amount over the 70 percent grant limitation requirement if
- 1.19 necessary to limit a farmer's cost per tractor to no more than \$500.
- 1.20 (c) Schools are eligible for grants that cover the full amount of a school's documented
- 1.21 cost to purchase, ship, and install an eligible rollover protective structure.
- 1.22 (d) A rollover protective structure is eligible if it is certified to appropriate national or
- 1.23 international rollover protection structure standards with a seat belt.
- 1.24 (e) "Eligible tractor" means a tractor that was built before 1987.

A person who is required by statutes administered by the Department of Agriculture, or 2.22 by rules adopted pursuant to those statutes, to provide a suitable water supply, or plumbing 2.23 or sewage disposal system shall not engage in the business of manufacturing, processing, 2.24 selling, handling, or storing food at wholesale or retail unless the person's water supply is 2.25 satisfactory pursuant to rules adopted by the Department of Health, the person's plumbing 2.26 is satisfactory pursuant to rules adopted by the Department of Labor and Industry, and the 2.27 person's sewage disposal system satisfies the rules of the Pollution Control Agency. This 2.28 section does not limit the commissioner's ability to issue a food handler's license when an 2.29 investigation completed pursuant to section 28A.07 has determined the requirements of this 2.30 section are not relevant and the applicant is considered fit to engage in business as described 2.31 in the license application. 2.32
