1.21 Section 1. 120B.126 CONSTRUCTION AND SKILLED TRADES COUNSELING.

1.22 The commissioner of education must collaborate with the commissioner of labor and
1.23 industry to incorporate construction and skilled trades into career counseling services for
1.24 middle and high school aged students. Career advisement should identify high-growth,
1.25 in-demand skilled trades and include information on various career paths and associated
1.26 jobs, the salary profiles of those jobs, and the credentials and other training desired by
1.27 employers for those jobs.
