1.1 A bill for an act

1.2 relating to capital investment; appropriating money for construction of community

1.3 spaces and 311 and 911 facilities in Minneapolis; authorizing the sale and issuance

1.4 of state bonds.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. **MINNEAPOLIS; COMMUNITY SPACES AND 311 AND 911**

1.7 **FACILITIES.**

1.8 Subdivision 1. **Appropriation.** (a) \$20,130,000 is appropriated from the bond proceeds

1.9 fund to the commissioner of employment and economic development for a grant to the city

1.10 of Minneapolis to acquire right-of-way, predesign, design, and construct, or reconstruct,

1.11 public right-of-way, community space, public infrastructure, and public facilities for 311

1.12 and 911 services. The city must engage in a community-led inclusive decision-making

1.13 process around the design of the public community spaces and public infrastructure projects.

1.14 (b) \$5,000,000 of this appropriation is to predesign, design, engineer, and construct a

1.15 public memorial and to reconstruct the intersection of 38th Street and Chicago Avenue in

1.16 Minneapolis.

1.17 (c) \$1,580,000 of this appropriation is to restore right-of-way and streetscaping in areas

1.18 of north and south Minneapolis which sustained damages and destruction from civil unrest

1.19 events after May 24, 2020, and before June 16, 2020.

1.20 (d) \$750,000 of this appropriation is to predesign, design, engineer, and construct a

1.21 public space on 27th Avenue South between Lake Street and Minnehaha Avenue South in

1.22 Minneapolis.

2.1 (e) \$5,500,000 of this appropriation is to predesign, design, engineer, and construct a
2.2 bicycle and pedestrian bridge over I-94 in north Minneapolis to further connect
2.3 neighborhoods that have been intentionally isolated from the Mississippi River and economic
2.4 activity.

2.5 (f) \$2,300,000 of this appropriation is to predesign, design, and construct improvements
2.6 to the intersection of Hiawatha Avenue and Lake Street in Minneapolis.

2.7 (g) \$5,000,000 of this appropriation is to design, engineer, and construct a facility for
2.8 311 and 911 services in Minneapolis.

2.9 Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond
2.10 proceeds fund, the commissioner of management and budget shall sell and issue bonds of
2.11 the state in an amount up to \$20,130,000 in the manner, upon the terms, and with the effect
2.12 prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota
2.13 Constitution, article XI, sections 4 to 7.

2.14 **EFFECTIVE DATE.** This section is effective the day following final enactment.
