1.8	Section 1. Minnesota Statutes 2012, section 201.014, is amended by adding a
1.9	subdivision to read:
1.10	Subd. 2a. Felony conviction; restoration of civil rights. (a) For purposes of
1.11	this section, an individual convicted of a felony is restored to civil rights as soon as the
1.12	individual completes any incarceration imposed and executed by the court for the offense.
1.13	If the individual is later incarcerated for the same offense, the individual's civil rights are
1.14	lost only during the period of incarceration.
1.15	(b) If an individual was convicted of a felony crime but was not incarcerated for the
1.16	felony conviction, the individual's civil rights are not removed.
1.17	Sec. 2. Minnesota Statutes 2012, section 201.071, subdivision 1, is amended to read:
1.18	Subdivision 1. Form. A voter registration application must be of suitable size and
1.19	weight for mailing and contain spaces for the following required information: voter's first
1.20	name, middle name, and last name; voter's previous name, if any; voter's current address;
1.21	voter's previous address, if any; voter's date of birth; voter's municipality and county
1.22	of residence; voter's telephone number, if provided by the voter; date of registration;
1.23	current and valid Minnesota driver's license number or Minnesota state identification

Sec. 5. Minnesota Statutes 2012, section 204C.08, subdivision 1d, is amended to read:
Subd. 1d. Voter's Bill of Rights. The county auditor shall prepare and provide to
each polling place sufficient copies of a poster setting forth the Voter's Bill of Rights as set
forth in this section. Before the hours of voting are scheduled to begin, the election judges
shall post it in a conspicuous location or locations in the polling place. The Voter's Bill
of Rights is as follows:

For all persons residing in this state who meet federal voting eligibility requirements:
(1) You have the right to be absent from work for the purpose of voting without
reduction to your pay, personal leave, or vacation time on election day for the time
necessary to appear at your polling place, cast a ballot, and return to work.

"VOTER'S BILL OF RIGHTS

3.29 (2) If you are in line at your polling place any time before 8:00 p.m., you have the3.30 right to vote.

3.31 (3) If you can provide the required proof of residence, you have the right to register3.32 to vote and to vote on election day.

6.1	Subdivision 1. Restoration. (a) When a person has been deprived of civil rights by
6.2	reason of conviction of a crime and is thereafter discharged, such discharge shall restore the
6.3	person to all civil rights and to full citizenship, with full right to vote and hold office, the
6.4	same as if such conviction had not taken place, and the order of discharge shall so provide.
6.5	(b) Section 201.014, subdivision 2a, governs the restoration of voting rights for
6.6	persons whose right to vote has been lost due to a felony conviction.
