1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. HUMAN SERVICES FORECAST ADJUSTMENTS.

1.6 The sums shown in the columns marked "Appropriations" are added to or, if shown in

1.7 parentheses, subtracted from the appropriations in Laws 2023, chapter 61, article 9, and

1.8 Laws 2023, chapter 70, article 20, to the commissioner of human services from the general

1.9 fund or other named fund for the purposes specified in section 2 and are available for the

1.10 fiscal years indicated for each purpose. The figures "2024" and "2025" used in this article

1.11 mean that the addition to or subtraction from the appropriation listed under them is available

1.12 for the fiscal year ending June 30, 2024, or June 30, 2025, respectively.
