1.1 A bill for an act  
1.2 relating to health licensing; providing temporary licensing as an LPC, LPCC,  
1.3 or LADC for former and current members of the military; amending Minnesota  
1.4 Statutes 2014, sections 148B.53, by adding a subdivision; 148B.5301, by adding  
1.5 a subdivision; 148F.025, by adding a subdivision.

1.6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.7 Section 1. Minnesota Statutes 2014, section 148B.53, is amended by adding a  
1.8 subdivision to read:

1.9 Subd. 1a. **Expedited and temporary licensing for former and current members**  
1.10 **of the military.** (a) Applicants seeking licensure according to this subdivision must be:

1.11 (1) an active duty military member;

1.12 (2) the spouse of an active duty military member; or

1.13 (3) a veteran who has left service in the two years preceding the date of license or  
1.14 certification application, and has confirmation of an honorable or general discharge status.

1.15 (b) A qualified applicant under this subdivision must provide evidence of:

1.16 (1) a current valid license, certificate, or permit in another state without history of  
1.17 disciplinary action by a regulatory authority in the other state; and

1.18 (2) a current criminal background study without a criminal conviction that is  
1.19 determined by the board to adversely affect the applicant's ability to become licensed.

1.20 (c) A temporary license issued under this subdivision is effective for one year from  
1.21 the initial licensure date.

1.22 (d) During the temporary license period, the individual shall complete the licensed  
1.23 professional counselor application for licensure.

1.24 (e) In order to remain licensed after the expiration of the temporary license, an  
1.25 individual must meet the requirements in subdivision 1, paragraphs (a) and (b).

2.6 (2) the spouse of an active duty military member; or  
2.7 (3) a veteran who has left service in the two years preceding the date of license or  
2.8 certification application, and has confirmation of an honorable or general discharge status.  
2.9 (b) A qualified applicant under paragraph (a) must provide evidence of:  
2.10 (1) a current valid license, certificate, or permit in another state without history of  
2.11 disciplinary action by a regulatory authority in the other state; and  
2.12 (2) a current criminal background study without a criminal conviction that is  
2.13 determined by the board to adversely affect the applicant's ability to become licensed.  
2.14 (c) A temporary license issued under this subdivision is effective for one year from  
2.15 the initial licensure date.

2.22 Subd. 5. **Expedited and temporary licensing for former and current members**  
2.23 **of the military.** (a) Applicants seeking licensure according to this subdivision must be:  
2.24 (1) an active duty military member;  
2.25 (2) the spouse of an active duty military member; or  
2.26 (3) a veteran who has left service in the two years preceding the date of license or  
2.27 certification application, and has confirmation of an honorable or general discharge status.  
2.28 (b) Applicants are required to comply with subdivisions 1 and 4.  
2.29 (c) A qualified applicant under paragraph (a) must provide evidence of:  
2.30 (1) a current valid license, certificate, or permit in another state without history of  
2.31 disciplinary action by a regulatory authority in the other state; and  
2.32 (2) a current criminal background study without a criminal conviction that is  
2.33 determined by the board to adversely affect the applicant's ability to become licensed.  
2.34 (d) A temporary license issued under this subdivision is effective for two years from  
2.35 the initial licensure date.
