1.37 We, the undersigned conferees for H. F. No. 5237 report that we have agreed upon the  
1.38 items in dispute and recommend as follows:

2.1 That the Senate recede from its amendments and that H. F. No. 5237 be further amended  
2.2 as follows:

2.3 Delete everything after the enacting clause and insert:

2.4 **"ARTICLE 1**  
2.5 **GENERAL EDUCATION**

2.6 Section 1. Minnesota Statutes 2022, section 120A.41, is amended to read:

2.7 **120A.41 LENGTH OF SCHOOL YEAR; HOURS OF INSTRUCTION.**

2.8 (a) A school board's annual school calendar must include at least 425 hours of instruction  
2.9 for a kindergarten student ~~without a disability~~, 935 hours of instruction for a student in  
2.10 grades 1 through 6, and 1,020 hours of instruction for a student in grades 7 through 12, not  
2.11 including summer school. The school calendar for all-day kindergarten must include at least  
2.12 850 hours of instruction for the school year. The school calendar for a prekindergarten  
2.13 student under section 124D.151, if offered by the district, must include at least 350 hours  
2.14 of instruction for the school year. A school board's annual calendar must include at least  
2.15 165 days of instruction for a student in grades 1 through 11 unless a four-day week schedule  
2.16 has been approved by the commissioner under section 124D.126.

2.17 (b) A school board's annual school calendar may include plans for up to five days of  
2.18 instruction provided through online instruction due to inclement weather. The inclement  
2.19 weather plans must be developed according to section 120A.414.

2.20 **EFFECTIVE DATE.** This section is effective for the 2023-2024 school year and later.

2.21 Sec. 2. Minnesota Statutes 2023 Supplement, section 123B.92, subdivision 11, is amended  
2.22 to read:

2.23 Subd. 11. **Area learning center transportation aid.** (a) A district or cooperative unit  
2.24 under section 123A.24, subdivision 2, that provides transportation of pupils to and from an  
2.25 area learning center program established under section 123A.05 is eligible for state aid to  
2.26 reimburse the additional costs of transportation during the preceding fiscal year.

2.27 (b) A district or cooperative unit under section 123A.24, subdivision 2, may apply to  
2.28 the commissioner of education for state aid to reimburse the costs of transporting pupils  
2.29 who are enrolled in an area learning center program established under section 123A.05  
2.30 during the preceding fiscal year. The commissioner shall develop the form and manner of  
2.31 applications for state aid, the criteria to determine when transportation is necessary, and the  
2.32 accounting procedure to determine excess costs. In determining aid amounts, the

3.3 (c) The total aid entitlement for this section is \$1,000,000 each year. The commissioner

3.5 cooperative unit under section 123A.24, subdivision 2.

3.28 ~~(d)~~ A pupil ceases to generate state English learner aid in the school year following the  
3.29 school year in which the pupil attains the state cutoff score on a commissioner-provided  
3.30 assessment that measures the pupil's emerging academic English.

4.3 Subd. 5a. **English learner cross subsidy aid.** (a) For fiscal year 2027 and later, a district's

4.5 subsidy calculated under paragraph (b).

4.6 (b) A district's English learner cross subsidy equals the greater of zero or the difference  
4.7 between the district's expenditures for qualifying English learner services for the second  
4.8 previous year and the district's English learner revenue under subdivision 5 for the second  
4.9 previous year. For the purposes of this subdivision, "qualifying English learner services"  
4.10 means the services necessary to implement the language instruction educational program  
4.11 for students identified as English learners under sections 124D.58 to 124D.65. Only  
4.12 expenditures that both address the English language development standards in Minnesota  
4.13 Rules, parts 3501.1200 and 3501.1210, which may include home language instruction, and  
4.14 are supplemental to the cost of core content instruction may be included as expenditures  
4.15 for qualifying English learner services. Expenditures do not include costs related to  
4.16 construction, indirect costs, core content instruction, or core administrative personnel.

 5.7 year for an elementary student, more than 850 hours in a school year for a kindergarten  
 5.8 student ~~without a disability~~ in an all-day kindergarten program, or more than 425 hours in

 5.26 an area learning center or alternative learning program must reserve revenue in an amount

6.1 (ii) General education revenue for a pupil in a state-approved alternative program without  
6.2 an independent study component must be prorated for a pupil participating for less than a  
6.3 full year, or its equivalent. The district must develop a continual learning plan for the pupil,  
6.4 consistent with section 124D.128, subdivision 3. Each school district that has an area learning  
6.5 center or alternative learning program must reserve revenue in an amount equal to at least  
6.6 90 and not more than 100 percent of the district average general education revenue per pupil  
6.7 unit, minus an amount equal to the product of the formula allowance according to section  
6.8 126C.10, subdivision 2, times .0466, calculated without basic skills revenue, local optional  
6.9 revenue, and transportation sparsity revenue, times the number of pupil units generated by  
6.10 students attending an area learning center or alternative learning program. The amount of

6.17 and each hour of independent study time completed toward a credit or graduation standards  
6.18 necessary for graduation. Average daily membership for a pupil shall equal the number of  
6.19 hours of teacher contact time and independent study time divided by 1,020.

6.20 (iv) For a state-approved alternative program having an independent study component,  
6.21 the commissioner shall require a description of the courses in the program, the kinds of  
6.22 independent study involved, the expected learning outcomes of the courses, and the means  
6.23 of measuring student performance against the expected outcomes.

6.29 A district's first tier local optional revenue equals \$300 times the adjusted pupil units of the  
6.30 district for that school year. A district's second tier local optional revenue equals \$424 times  
6.31 the adjusted pupil units of the district for that school year.

6.32 (b) A district's local optional levy equals the sum of the first tier local optional levy and  
6.33 the second tier local optional levy.

(2) the noncompliance does not imminently endanger the health, safety, or rights of the persons served by the program; and

(3) the license holder did not receive documented technical assistance or a correction order for the same violation at the license holder's most recent annual licensing inspection.

(b) Documented technical assistance must include communication from the commissioner to the license holder that:

(1) states the conditions that constitute a violation of a law or rule;

(2) references the specific law or rule violated; and

(3) explains remedies for correcting the violation.

(c) The commissioner shall not publicly publish documented technical assistance on the department's website.
