be necessary to conduct such shop, or the barbering service of such school or college, in a
sanitary manner, or the failure or refusal of any such person to have water and sewer
connections from such shop, or barber school or college, with municipal water and sewer
systems where the latter are available for use, or the failure or refusal of any such person
to maintain a receptacle for hot water of a capacity of not less than five gallons;

(9) For the purposes of this section, barbers, students, apprentices, or the proprietor or 12.12 manager of a barber shop, or barber school or barber college, shall be responsible for all 12.13 violations of the sanitation and disinfection provisions of this section. If any barber 12.14 workstation in any barber shop, or barber school or barber college, upon inspection, shall 12.15 be found to be in an unsanitary condition, the person making such inspection shall 12.16 immediately issue an order to place the barber shop, or barber school, or barber college, in 12.17 a sanitary condition, in a manner and within a time satisfactory to the Board of Barber 12.18 Examiners, and for the failure to comply with such order the board shall immediately file 12.19 a complaint for the arrest of the persons upon whom the order was issued, and any registered 12.20 barber who shall fail to comply with the rules adopted by the Board of Barber Examiners, 12.21 with the approval of the state commissioner of health, or the violation or commission of 12.22 any of the offenses described in this section and section 154.161, subdivision 4, paragraph 12.23 (a), clauses (1), (3), and (4) to (12), shall be fined not less than \$10 or imprisoned for ten 12.24 days and not more than \$100 or imprisoned for 90 days. 12.25

#### 12.27 **154.24 RULES.**

The Board of Barber Examiners shall have authority to make reasonable rules for the administration of the provisions of sections 154.001, 154.002, 154.003, 154.01 to 154.162, 154.19 to 154.21, and 154.24 to 154.28 and prescribe sanitation and disinfection requirements for barber shops and barber schools, subject to the approval of the state commissioner of health. Any member of the board, or its agents or assistants, shall have authority to enter upon and to inspect any barber shop or barber school at any time during business hours. A copy of the rules adopted by the board shall be furnished by it to the owner or manager of

- each barber shop or barber school and such copy shall be posted in a conspicuous place insuch barber shop or barber school.
- 13.3 The board shall keep a record of its proceedings relating to the issuance, refusal, renewal,
- 13.4 suspension, and revocation of certificates of registration. This record shall contain the name,
- 13.5 place of business, and residence of each registered barber and registered apprentice, and
- 13.6 the date and number of the certificate of registration. This record shall be open to public
- 13.7 inspection at all reasonable times.
