2.17 Section 1. Minnesota Statutes 2016, section 40A.18, subdivision 2, is amended to read:

2.18 **Subd. 2. Allowed commercial and industrial operations.** (a) Commercial and industrial
2.19 operations are not allowed on land within an agricultural preserve except:

2.20 (1) small on-farm commercial or industrial operations normally associated with and
2.21 important to farming in the agricultural preserve area;

2.22 (2) storage use of existing farm buildings that does not disrupt the integrity of the
2.23 agricultural preserve; and

2.24 (3) small commercial use of existing farm buildings for trades not disruptive to the
2.25 integrity of the agricultural preserve such as a carpentry shop, small scale mechanics shop,
2.26 and similar activities that a farm operator might conduct; and

2.27 (4) wireless communication installations and related equipment and structure capable
2.28 of providing technology potentially beneficial to farming activities.

2.29 (b) For purposes of paragraph (a), clauses (2) and (3), "existing" in clauses (2) and (3)
2.30 means existing on August 1, 1989.

2.31 **EFFECTIVE DATE.** This section is effective the day following final enactment.

Sec. 2. **[103C.333] COUNTY LEVY AUTHORITY.**

2.33 Notwithstanding any other law to the contrary, a county levying a tax under section
2.34 103C.331 shall not include any taxes levied under those authorities in the levy certified

3.18 Subd. 86. **Apprenticeship training facilities.** All or a portion of a building used
3.19 exclusively for a state-approved apprenticeship program through the Department of Labor
3.20 and Industry is exempt if:

3.21 (1) it is owned by a nonprofit organization or a nonprofit trust, and operated by a nonprofit
3.22 organization or a nonprofit trust;

3.23 (2) the program participants receive no compensation; and

3.24 (3) it is located:

3.25 (i) in the Minneapolis and St. Paul standard metropolitan statistical area as determined
3.26 by the 2000 federal census;

3.27 (ii) in a city outside the Minneapolis and St. Paul standard metropolitan statistical area
3.28 that has a population of 7,400 or greater according to the most recent federal census; or

3.29 (iii) in a township that has a population greater than ~~2,000~~ 1,400 but less than 3,000
3.30 determined by the 2000 federal census and the building was previously used by a school
3.31 and was exempt for taxes payable in 2010.

4.1 Use of the property for advanced skills training of incumbent workers does not disqualify
4.2 the property for the exemption under this subdivision. This exemption includes up to five
4.3 acres of the land on which the building is located and associated parking areas on that land,
4.4 except that if the building meets the requirements of clause (3), item (iii), then the exemption
4.5 includes up to ten acres of land on which the building is located and associated parking
4.6 areas on that land. If a parking area associated with the facility is used for the purposes of
4.7 the facility and for other purposes, a portion of the parking area shall be exempt in proportion
4.8 to the square footage of the facility used for purposes of apprenticeship training.

4.11 Subd. 100. Electric generation facility; personal property. (a) Notwithstanding

4.13 electric generation facility with more than 35 megawatts and less than 40 megawatts of
4.14 installed capacity and that meets the requirements of this subdivision is exempt from taxation
4.15 and payments in lieu of taxation. The facility must:

4.16 (1) be designed to utilize natural gas as a primary fuel;

4.17 (2) be owned and operated by a municipal power agency as defined in section 453.52,
4.18 subdivision 8;

4.19 (3) be located within 800 feet of an existing natural gas pipeline;

4.20 (4) satisfy a resource deficiency identified in an approved integrated resource plan filed
4.21 under section 216B.2422;

4.22 (5) be located outside the metropolitan area as defined under section 473.121, subdivision
4.23 2; and

4.24 (6) have received, by resolution, the approval of the governing bodies of the city and
4.25 county in which it is located for the exemption of personal property provided by this
4.26 subdivision.

4.27 (b) Construction of the facility must have been commenced after January 1, 2015, and
4.28 before January 1, 2017. Property eligible for this exemption does not include electric
4.29 transmission lines and interconnections or gas pipelines and interconnections appurtenant
4.30 to the property or the facility.

4.31 **EFFECTIVE DATE.** This section is effective the day following final enactment.

5.2 **272.0213 LEASED SEASONAL-RECREATIONAL LAND.**

5.3 (a) ~~A county board may elect, by resolution, to Qualified lands, as defined in this section,~~
5.4 ~~are~~ exempt from taxation, including the tax under section 273.19, ~~qualified lands~~. "Qualified
5.5 lands" for purposes of this section means ~~property land~~ that:

5.6 (1) is owned by a county, city, town, or the state; and

5.7 (2) is rented by the entity for noncommercial seasonal-recreational ~~or~~, noncommercial
5.8 seasonal-recreational residential use; ~~and, or class 1c commercial seasonal-recreational~~

5.18 Subd. 2. **Definitions.** (a) For the purposes of this section, the term:

5.19 (1) "wind energy conversion system" has the meaning given in section 216C.06,
5.20 subdivision 19, and also includes a substation that is used and owned by one or more wind
5.21 energy conversion facilities;

5.22 (2) "large scale wind energy conversion system" means a wind energy conversion system
5.23 of more than 12 megawatts, as measured by the nameplate capacity of the system or as
5.24 combined with other systems as provided in paragraph (b);

5.25 (3) "medium scale wind energy conversion system" means a wind energy conversion
5.26 system of over two and not more than 12 megawatts, as measured by the nameplate capacity
5.27 of the system or as combined with other systems as provided in paragraph (b); and

5.28 (4) "small scale wind energy conversion system" means a wind energy conversion system
5.29 of two megawatts and under, as measured by the nameplate capacity of the system or as
5.30 combined with other systems as provided in paragraph (b).

6.1 (b) For systems installed and contracted for after January 1, 2002, the total size of a
6.2 wind energy conversion system under this subdivision shall be determined according to this
6.3 paragraph. Unless the systems are interconnected with different distribution systems, the
6.4 nameplate capacity of one wind energy conversion system shall be combined with the
6.5 nameplate capacity of any other wind energy conversion system that is:

- 6.6 (1) located within five miles of the wind energy conversion system;
6.7 (2) constructed within the same calendar year as the wind energy conversion system;
6.8 and
6.9 (3) under common ownership.

6.10 In the case of a dispute, the commissioner of commerce shall determine the total size of

6.12 (c) In making a determination under paragraph (b), the commissioner of commerce may
6.13 determine that two wind energy conversion systems are under common ownership when
6.14 the underlying ownership structure contains similar the same persons or entities, even if the
6.15 ownership shares differ between the two systems. Wind energy conversion systems are not
6.16 under common ownership solely because the same person or entity provided equity financing
6.17 for the systems. Wind energy conversion systems that were determined by the commissioner
6.18 of commerce to be eligible for a renewable energy production incentive under section
6.19 216C.41 are not under common ownership unless a change in the qualifying owner was
6.20 made to an owner of another wind energy conversion system subsequent to the determination
6.21 by the commissioner of commerce.

6.24 **272.162 RESTRICTIONS ON TRANSFERS OF SPECIFIC PARTS.**

6.25 Subdivision 1. **Conditions restricting transfer.** When a deed or other instrument
6.26 conveying a parcel of land is presented to the county auditor for transfer or division under
6.27 sections 272.12, 272.16, and 272.161, the auditor shall not transfer or divide the land or its
6.28 net tax capacity in the official records and shall not certify the instrument as provided in
6.29 section 272.12, if:

- 6.30 (a) The land conveyed is less than a whole parcel of land as charged in the tax lists;

7.1 (b) The part conveyed appears within the area of application of municipal or county
7.2 subdivision regulations adopted and filed under section 394.35 or section 462.36, subdivision
7.3 1; and

7.4 (c) The part conveyed is part of or constitutes a subdivision as defined in section 462.352,
7.5 subdivision 12.

7.6 Subd. 2. **Conditions allowing transfer.** (a) Notwithstanding the provisions of subdivision
7.7 1, the county auditor may transfer or divide the land and its net tax capacity and may certify
7.8 the instrument if the instrument contains a certification by the clerk of the municipality or
7.9 designated county planning official:

7.10 (a) (1) that the municipality's or county's subdivision regulations do not apply;

7.22 (c) If an unexecuted instrument is presented to the municipality or county and any of
7.23 the conditions for certification by the municipality or county as provided in this subdivision
7.24 exist, the unexecuted instrument must be certified by the clerk of the municipality or the
7.25 designated county planning official.

7.26 Subd. 3. **Applicability of restrictions.** (a) This section does not apply to the exceptions
7.27 set forth in section 272.12.

7.28 (b) This section applies only to land within municipalities or counties which choose to
7.29 be governed by its provisions. A municipality or county may choose to have this section
7.30 apply to the property within its boundaries by filing a certified copy of a resolution of its
7.31 governing body making that choice with the auditor and recorder of the county in which it
7.32 is located.

7.33 **EFFECTIVE DATE.** This section is effective the day following final enactment.

8.1 Sec. 9. Minnesota Statutes 2016, section 273.124, subdivision 3a, is amended to read:

8.2 **Subd. 3a. Manufactured home park cooperative.** (a) When a manufactured home park
8.3 is owned by a corporation or association organized under chapter 308A or 308B, and each
8.4 person who owns a share or shares in the corporation or association is entitled to occupy a
8.5 lot within the park, the corporation or association may claim homestead treatment for the
8.6 park. Each lot must be designated by legal description or number, and each lot is limited to
8.7 not more than one-half acre of land.

8.8 (b) The manufactured home park shall be entitled to homestead treatment if all of the
8.9 following criteria are met:

8.10 (1) the occupant or the cooperative corporation or association is paying the ad valorem
8.11 property taxes and any special assessments levied against the land and structure either
8.12 directly, or indirectly through dues to the corporation or association; and

8.13 (2) the corporation or association organized under chapter 308A or 308B is wholly
8.14 owned by persons having a right to occupy a lot owned by the corporation or association.

8.15 (c) A charitable corporation, organized under the laws of Minnesota with no outstanding
8.16 stock, and granted a ruling by the Internal Revenue Service for 501(c)(3) tax-exempt status,
8.17 qualifies for homestead treatment with respect to a manufactured home park if its members
8.18 hold residential participation warrants entitling them to occupy a lot in the manufactured
8.19 home park.

8.20 (d) "Homestead treatment" under this subdivision means the classification rate provided
8.21 for class 4c property classified under section 273.13, subdivision 25, paragraph (d), clause
8.22 (5), item (ii), and the homestead market value exclusion under section 273.13, subdivision
8.23 35, does not apply and the property taxes assessed against the park shall not be included in
8.24 the determination of taxes payable for rent paid under section 290A.03.

8.25 **EFFECTIVE DATE.** This section is effective beginning with claims for taxes payable
8.26 in 2018.

8.27 Sec. 10. Minnesota Statutes 2016, section 273.124, subdivision 14, is amended to read:

8.28 **Subd. 14. Agricultural homesteads; special provisions.** (a) Real estate of less than ten
8.29 acres that is the homestead of its owner must be classified as class 2a under section 273.13,
8.30 subdivision 23, paragraph (a), if:

8.31 (1) the parcel on which the house is located is contiguous on at least two sides to (i)
8.32 agricultural land, (ii) land owned or administered by the United States Fish and Wildlife

9.1 Service, or (iii) land administered by the Department of Natural Resources on which in lieu
9.2 taxes are paid under sections 477A.11 to 477A.14;

9.3 (2) its owner also owns a noncontiguous parcel of agricultural land that is at least 20
9.4 acres;

9.5 (3) the noncontiguous land is located not farther than four townships or cities, or a
9.6 combination of townships or cities from the homestead; and

9.7 (4) the agricultural use value of the noncontiguous land and farm buildings is equal to
9.8 at least 50 percent of the market value of the house, garage, and one acre of land.

9.9 Homesteads initially classified as class 2a under the provisions of this paragraph shall
9.10 remain classified as class 2a, irrespective of subsequent changes in the use of adjoining
9.11 properties, as long as the homestead remains under the same ownership, the owner owns a
9.12 noncontiguous parcel of agricultural land that is at least 20 acres, and the agricultural use
9.13 value qualifies under clause (4). Homestead classification under this paragraph is limited
9.14 to property that qualified under this paragraph for the 1998 assessment.

9.15 (b)(i) Agricultural property shall be classified as the owner's homestead, to the same
9.16 extent as other agricultural homestead property, if all of the following criteria are met:

9.17 (1) the agricultural property consists of at least 40 acres including undivided government
9.18 lots and correctional 40's;

9.19 (2) the owner, the owner's spouse, or a grandchild, child, sibling, or parent of the owner
9.20 or of the owner's spouse, is actively farming the agricultural property, either on the person's
9.21 own behalf as an individual or on behalf of a partnership operating a family farm, family
9.22 farm corporation, joint family farm venture, or limited liability company of which the person
9.23 is a partner, shareholder, or member;

9.24 (3) both the owner of the agricultural property and the person who is actively farming
9.25 the agricultural property under clause (2), are Minnesota residents;

9.26 (4) neither the owner nor the spouse of the owner claims another agricultural homestead
9.27 in Minnesota; and

9.28 (5) neither the owner nor the person actively farming the agricultural property lives
9.29 farther than four townships or cities, or a combination of four townships or cities, from the
9.30 agricultural property, except that if the owner or the owner's spouse is required to live in
9.31 employer-provided housing, the owner or owner's spouse, whichever is actively farming
9.32 the agricultural property, may live more than four townships or cities, or combination of
9.33 four townships or cities from the agricultural property.

10.1 The relationship under this paragraph may be either by blood or marriage.

10.2 (ii) ~~Agricultural property held by a trustee under a trust is eligible for agricultural homestead classification under this paragraph if the qualifications in clause (i) are met, except that "owner" means the grantor of the trust.~~

10.5 (iii) Property containing the residence of an owner who owns qualified property under clause (i) shall be classified as part of the owner's agricultural homestead, if that property is also used for noncommercial storage or drying of agricultural crops.

10.8 (iv) (iii) As used in this paragraph, "agricultural property" means class 2a property and any class 2b property that is contiguous to and under the same ownership as the class 2a property.

10.11 (c) Noncontiguous land shall be included as part of a homestead under section 273.13, subdivision 23, paragraph (a), only if the homestead is classified as class 2a and the detached land is located in the same township or city, or not farther than four townships or cities or combination thereof from the homestead. Any taxpayer of these noncontiguous lands must notify the county assessor that the noncontiguous land is part of the taxpayer's homestead, and, if the homestead is located in another county, the taxpayer must also notify the assessor of the other county.

10.18 (d) Agricultural land used for purposes of a homestead and actively farmed by a person holding a vested remainder interest in it must be classified as a homestead under section 273.13, subdivision 23, paragraph (a). If agricultural land is classified class 2a, any other dwellings on the land used for purposes of a homestead by persons holding vested remainder interests who are actively engaged in farming the property, and up to one acre of the land surrounding each homestead and reasonably necessary for the use of the dwelling as a home, must also be assessed class 2a.

10.25 (e) Agricultural land and buildings that were class 2a homestead property under section 273.13, subdivision 23, paragraph (a), for the 1997 assessment shall remain classified as agricultural homesteads for subsequent assessments if:

10.28 (1) the property owner abandoned the homestead dwelling located on the agricultural homestead as a result of the April 1997 floods;

10.30 (2) the property is located in the county of Polk, Clay, Kittson, Marshall, Norman, or Wilkin;

11.1 (3) the agricultural land and buildings remain under the same ownership for the current
11.2 assessment year as existed for the 1997 assessment year and continue to be used for
11.3 agricultural purposes;

11.4 (4) the dwelling occupied by the owner is located in Minnesota and is within 30 miles
11.5 of one of the parcels of agricultural land that is owned by the taxpayer; and

11.6 (5) the owner notifies the county assessor that the relocation was due to the 1997 floods,
11.7 and the owner furnishes the assessor any information deemed necessary by the assessor in
11.8 verifying the change in dwelling. Further notifications to the assessor are not required if the
11.9 property continues to meet all the requirements in this paragraph and any dwellings on the
11.10 agricultural land remain uninhabited.

11.11 (f) Agricultural land and buildings that were class 2a homestead property under section
11.12 273.13, subdivision 23, paragraph (a), for the 1998 assessment shall remain classified
11.13 agricultural homesteads for subsequent assessments if:

11.14 (1) the property owner abandoned the homestead dwelling located on the agricultural
11.15 homestead as a result of damage caused by a March 29, 1998, tornado;

11.16 (2) the property is located in the county of Blue Earth, Brown, Cottonwood, LeSueur,
11.17 Nicollet, Nobles, or Rice;

11.18 (3) the agricultural land and buildings remain under the same ownership for the current
11.19 assessment year as existed for the 1998 assessment year;

22.17 agricultural products for sale to local markets by the farmer or an organization with which
22.18 the farmer is affiliated.

22.19 "Contiguous acreage," for purposes of this paragraph, means all of a tax parcel as
22.20 described in section 272.193, or all of a set of contiguous tax parcels under that section that

22.22 (g) Land shall be classified as agricultural even if all or a portion of the agricultural use
