BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.5

Section 1. Minnesota Statutes 2014, section 298.28, subdivision 2, is amended to read: 1.6 Subd. 2. City or town where quarried or produced. (a) 4.5 cents per gross ton of 1.7 merchantable iron ore concentrate, hereinafter referred to as "taxable ton," plus the amount 1.8 provided in paragraph (c) (d), must be allocated to the city or town in the county in which 1.9 the lands from which taconite was mined or quarried were located or within which the 1.10 concentrate was produced. If the mining, quarrying, and concentration, or different steps 1.11 in either thereof are carried on in more than one taxing district, the commissioner shall 1.12 apportion equitably the proceeds of the part of the tax going to cities and towns among 1.13 such subdivisions upon the basis of attributing 50 percent of the proceeds of the tax to 1.14 the operation of mining or quarrying the taconite, and the remainder to the concentrating 1.15 plant and to the processes of concentration, and with respect to each thereof giving due 1.16 consideration to the relative extent of such operations performed in each such taxing 1.17 district. (c) Four cents per taxable ton shall be allocated to cities and organized townships 2.6 affected by the production of merchantable iron ore concentrate because their boundaries 2.7 are within three miles of a facility engaged in production of merchantable iron ore 2.8 concentrate that has been actively producing or otherwise engaged in the production of 2.9 merchantable iron ore concentrate in at least one of the prior three years. If a city or town 2.10 is located near more than one merchantable iron ore concentrating facility meeting these 2.11 criteria, the city or town is eligible to receive aid calculated from only the merchantable 2.12 iron ore concentrating facility producing the largest taxable tonnage. When more than 2.13 one municipality qualifies for aid based on one company's production, the aid must be 2.14 apportioned among the municipalities in proportion to their populations.
