1.1 A bill for an act
1.2 relating to capital investment; authorizing spending to acquire and better land and
1.3 buildings and for other improvements of a capital nature with certain conditions;
1.4 canceling prior appropriations; appropriating money.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. CAPITAL IMPROVEMENT APPROPRIATIONS.

1.7 (a) The sums shown in the column under "Appropriations" are appropriated from the
1.8 general fund in fiscal year 2024 to the state agencies or officials indicated, to be spent for
1.9 public purposes. These are onetime appropriations. Money appropriated in this act is available
1.10 until the project is completed or abandoned, subject to Minnesota Statutes, section 16A.642.

1.11 (b) For any project funded in whole or in part by this act, workers on the project must
1.12 be paid at least the prevailing wage rate as defined in Minnesota Statutes, section 177.42,
1.13 subdivision 6, and the requirements of Minnesota Statutes, sections 177.27, 177.30, 177.32,
1.14 and 177.41 to 177.445 apply. For the purposes of this act, "project" means the acquisition
1.15 of property, predesign, design, erection, construction, remodeling, or repairing of a building,
1.16 facility, or other capital project financed in whole or part by state funds.

1.17 (c) Money appropriated in this act is available for a grant after the commissioner of
1.18 management and budget determines that an amount sufficient to complete the project as
1.19 described in this act has been committed to the project, as required by Minnesota Statutes,
1.20 section 16A.502.
