1.6	Section 1. Minnesota Statutes 2018, section 517.02, is amended to read:				
1.7	517.02 PERSONS CAPABLE OF CONTRACTING.				
1.8	Every A person who has attained the full age of 18 years is capable in law of contracting				
1.9	into a civil marriage, if otherwise competent. A person of the full age of 16 years may, with				
1.10	the consent of the person's legal custodial parents, guardian, or the court, as provided in				
1.11	section 517.08, receive a license to marry, when, after a careful inquiry into the facts and				
1.12	the surrounding circumstances, the person's application for a license and consent for civil				
1.13	marriage of a minor form is approved by the judge of the district court of the county in

Subd. 1b. Term of license; fee; premarital education. (a) The local registrar shall 4.11 examine upon oath the parties applying for a license relative to the legality of the 4.12 contemplated civil marriage. Both parties must present proof of age to the local registrar. 4.13 If one party is unable to appear in person, the party appearing may complete the absent 4.14 applicant's information. The local registrar shall provide a copy of the civil marriage 4.15 4.16 application to the party who is unable to appear, who must verify the accuracy of the appearing party's information in a notarized statement. The verification statement must be 4.17 accompanied by a copy of proof of age of the party. The civil marriage license must not be 4.18 released until the verification statement and proof of age has been received by the local 4.19 registrar. (b) The civil marriage license fee for parties who have completed at least 12 hours of

premarital education is \$40. In order to qualify for the reduced license fee, the parties must 5.2 submit at the time of applying for the civil marriage license a statement that is signed, dated, 5.3 and notarized or marked with a church seal from the person who provided the premarital 5.4 education on their letterhead confirming that it was received. The premarital education must 5.5 be provided by a licensed or ordained minister or the minister's designee, a person authorized 5.6 to solemnize civil marriages under section 517.18, or a person authorized to practice marriage 5.7 and family therapy under section 148B.33. The education must include the use of a premarital 5.8 inventory and the teaching of communication and conflict management skills. 5.9

5.10 (c) The statement from the person who provided the premarital education under paragraph5.11 (b) must be in the following form:

- 5.18 The names of the parties in the educator's statement must be identical to the legal names 5.19 of the parties as they appear in the civil marriage license application. Notwithstanding 5.20 section 138.17, the educator's statement must be retained for seven years, after which time 5.21 it may be destroyed.
- (d) If section 259.13 applies to the request for a civil marriage license, the local registrar
 shall grant the civil marriage license without the requested name change. Alternatively, the
 local registrar may delay the granting of the civil marriage license until the party with the
 conviction:
- (1) certifies under oath that 30 days have passed since service of the notice for a name
 change upon the prosecuting authority and, if applicable, the attorney general and no
 objection has been filed under section 259.13; or
- (2) provides a certified copy of the court order granting it. The parties seeking the civil
 marriage license shall have the right to choose to have the license granted without the name
 change or to delay its granting pending further action on the name change request.
