1.5	Section 1. AMERICANS WITH DISABILITIES ACT NOTICE TO BUSINESSES
1.6	WORKING GROUP.
1.7	Subdivision 1. Establishment. The Americans with Disabilities Act Notice to Businesses
1.8	Working Group is established to develop recommendations for providing notice to business
1.9	owners that standard building code inspections, plan reviews, and approvals do not guarantee
1.10	complete compliance with the accessibility requirements of the Americans with Disabilities
1.11	Act, the Minnesota Human Rights Act, or state building codes.

2.10	(2) the appropriate entity or entities responsible for providing the notice.

2.12	administrative support and meeting space for the working group.
