1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. [116J.9661] TRADE POLICY ADVISORY GROUP.
1.6	Subdivision 1. Establishment. The trade policy advisory group is established to
1.7	advise and assist the governor and the legislature regarding government procurement
1.8	agreements of United States trade agreements.
1.9	Subd. 2. Membership. (a) The trade policy advisory group shall be appointed by
1.10	the governor and comprised of 11 members as follows:
1.11	(1) two representatives of organized labor;
1.12	(2) a representative of an organization representing environmental interests;
1.13	(3) a representative of organizations representing family farmers;
1.14	(4) two representatives from business and industry;
1.15	(5) a representative of a nonprofit organization focused on international trade and
1.16	development;
1.17	(6) the commissioner of employment and economic development or designee;
1.18	(7) two senators, including one member from the majority party and one member
1.19	from the minority party, appointed by the Subcommittee on Committees of the Committee
