1.16 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.17 ARTICLE 1
1.18 TENANT'S RIGHT

1.19 Section 1. Minnesota Statutes 2022, section 363A.09, subdivision 1, is amended to read:

1.20 Subdivision 1. Real property interest; action by owner, lessee, and others. It is an
1.21 unfair discriminatory practice for an owner, lessee, sublessee, assignee, or managing agent
1.22 of, or other person having the right to sell, rent or lease any real property, or any agent of
1.23 any of these:

1.24 (1) to refuse to sell, rent, or lease or otherwise deny to or withhold from any person or
1.25 group of persons any real property because of race, color, creed, religion, national origin,
1.26 sex, marital status, status with regard to public assistance, participation in or requirements
1.27 of a public assistance program, disability, sexual orientation, or familial status; or

2.1 (2) to discriminate against any person or group of persons because of race, color, creed,
2.2 religion, national origin, sex, marital status, status with regard to public assistance,
2.3 participation in or requirements of a public assistance program, disability, sexual orientation,
2.4 or familial status in the terms, conditions or privileges of the sale, rental or lease of any real
2.5 property or in the furnishing of facilities or services in connection therewith, except that
2.6 nothing in this clause shall be construed to prohibit the adoption of reasonable rules intended
2.7 to protect the safety of minors in their use of the real property or any facilities or services
2.8 furnished in connection therewith; or

2.9 (3) in any transaction involving real property, to print, circulate or post or cause to be
2.10 printed, circulated, or posted any advertisement or sign, or use any form of application for
2.11 the purchase, rental or lease of real property, or make any record or inquiry in connection
2.12 with the prospective purchase, rental, or lease of real property which expresses, directly or
2.13 indirectly, any limitation, specification, or discrimination as to race, color, creed, religion,
2.14 national origin, sex, marital status, status with regard to public assistance, participation in
2.15 or requirements of a public assistance program, disability, sexual orientation, or familial
2.16 status, or any intent to make any such limitation, specification, or discrimination except that
2.17 nothing in this clause shall be construed to prohibit the advertisement of a dwelling unit as
2.18 available to adults-only if the person placing the advertisement reasonably believes that the
2.19 provisions of this section prohibiting discrimination because of familial status do not apply
2.20 to the dwelling unit.

2.21 Sec. 2. Minnesota Statutes 2022, section 363A.09, subdivision 2, is amended to read:

2.22 Subd. 2. **Real property interest; action by brokers, agents, and others.** It is an unfair
2.23 discriminatory practice for a real estate broker, real estate salesperson, or employee, or agent
2.24 thereof:

2.25 (1) to refuse to sell, rent, or lease or to offer for sale, rental, or lease any real property
2.26 to any person or group of persons or to negotiate for the sale, rental, or lease of any real
2.27 property to any person or group of persons because of race, color, creed, religion, national
2.28 origin, sex, marital status, status with regard to public assistance, participation in or
2.29 requirements of a public assistance program, disability, sexual orientation, or familial status
2.30 or represent that real property is not available for inspection, sale, rental, or lease when in
2.31 fact it is so available, or otherwise deny or withhold any real property or any facilities of
2.32 real property to or from any person or group of persons because of race, color, creed, religion,
2.33 national origin, sex, marital status, status with regard to public assistance, participation in

3.1 or requirements of a public assistance program, disability, sexual orientation, or familial
3.2 status; or

3.3 (2) to discriminate against any person because of race, color, creed, religion, national
3.4 origin, sex, marital status, status with regard to public assistance, participation in or
3.5 requirements of a public assistance program, disability, sexual orientation, or familial status
3.6 in the terms, conditions or privileges of the sale, rental or lease of real property or in the
3.7 furnishing of facilities or services in connection therewith; or

3.8 (3) to print, circulate, or post or cause to be printed, circulated, or posted any
3.9 advertisement or sign, or use any form of application for the purchase, rental, or lease of
3.10 any real property or make any record or inquiry in connection with the prospective purchase,
3.11 rental or lease of any real property, which expresses directly or indirectly, any limitation,
3.12 specification or discrimination as to race, color, creed, religion, national origin, sex, marital
3.13 status, status with regard to public assistance, participation in or requirements of a public
3.14 assistance program, disability, sexual orientation, or familial status or any intent to make
3.15 any such limitation, specification, or discrimination except that nothing in this clause shall
3.16 be construed to prohibit the advertisement of a dwelling unit as available to adults-only if
3.17 the person placing the advertisement reasonably believes that the provisions of this section
3.18 prohibiting discrimination because of familial status do not apply to the dwelling unit.

3.19 Sec. 3. Minnesota Statutes 2022, section 363A.09, is amended by adding a subdivision to
3.20 read:

3.21 Subd. 2a. **Definition; public assistance program.** For the purposes of this section,
3.22 "public assistance program" means federal, state, or local assistance, including but not
3.23 limited to rental assistance, rent supplements, and housing choice vouchers.

3.24 Sec. 4. Minnesota Statutes 2022, section 363A.21, subdivision 1, is amended to read:

3.25 Subdivision 1. **Housing.** (a) The provisions of section 363A.09 shall not apply to:

3.26 (1) rooms in a temporary or permanent residence home run by a nonprofit organization,
3.27 if the discrimination is by sex;

3.28 (2) the rental by a resident owner or occupier of a one-family accommodation of a room
3.29 or rooms in the accommodation to another person or persons if the discrimination is by sex,
3.30 marital status, status with regard to public assistance, participation in or requirements of a
3.31 public assistance program, sexual orientation, or disability. Except as provided elsewhere
3.32 in this chapter or other state or federal law, no person or group of persons selling, renting,

4.1 or leasing property is required to modify the property in any way, or exercise a higher degree
4.2 of care for a person having a disability than for a person who does not have a disability; nor
4.3 shall this chapter be construed to relieve any person or persons of any obligations generally
4.4 imposed on all persons regardless of any disability in a written lease, rental agreement, or
4.5 contract of purchase or sale, or to forbid distinctions based on the inability to fulfill the
4.6 terms and conditions, including financial obligations of the lease, agreement, or contract;

4.8 (3) the rental by a resident owner of a unit in a dwelling containing not more than two
4.9 units, if the discrimination is on the basis of sexual orientation.

4.10 (b) The provisions of section 363A.09 that prohibit discrimination on the basis of
4.11 participation in or requirements of a public assistance program shall not apply when:

4.12 (1) renting or leasing a room in a single-family unit;

4.13 (2) an individual owner of a single dwelling unit does not lease more than one dwelling
4.14 unit; or

4.15 (3) an individual owner of a single dwelling unit is renting that unit and when the owner
4.16 is on active military duty.

4.17 **Sec. 2. [504B.114] PET DECLAWING AND DEVOCALIZATION PROHIBITED.**

4.18 Subdivision 1. **Definitions.** (a) For purposes of this section, the following terms have
4.19 the meanings given.

4.20 (b) "Animal" has the meaning given in section 343.20, subdivision 2.

4.21 (c) "Application for occupancy" means all phases of the process of applying for the right
4.22 to occupy a real property, including but not limited to filling out applications, interviewing,
4.23 and submitting references.

4.24 (d) "Claw" means a hardened keratinized modification of the epidermis or a hardened
4.25 keratinized growth that extends from the end of the digits of certain mammals, birds, reptiles,
4.26 and amphibians that is commonly referred to as a claw, talon, or nail.

4.27 (e) "Declawing" means performing, procuring, or arranging for any procedure, such as
4.28 an onychectomy, tendonectomy, or phalangectomy, to remove or prevent the normal function
4.29 of an animal's claw or claws.

4.30 (f) "Devocalizing" means performing, procuring, or arranging for any surgical procedure,
4.31 such as a vocal cordectomy, to remove an animal's vocal cords or to prevent the normal
4.32 function of an animal's vocal cords.

5.1 Subd. 2. **Prohibitions.** A landlord who allows an animal on the premises shall not:

5.2 (1) advertise the availability of a real property for occupancy in a manner designed to
5.3 discourage application for occupancy of that real property because an applicant's animal
5.4 has not been declawed or devocalized;

5.5 (2) refuse to allow the occupancy of a real property, refuse to negotiate the occupancy
5.6 of a real property, or otherwise make unavailable or deny to another person the occupancy
5.7 of a real property because of that person's refusal to declaw or devocalize an animal; or

5.8 (3) require a tenant or occupant of real property to declaw or devocalize an animal
5.9 allowed on the premises.

5.10 Subd. 3. **Penalties.** (a) A city attorney, a county attorney, or the attorney general may
5.11 bring an action in district court to obtain injunctive relief for a violation of this section and
5.12 to enforce the civil penalties provided in this subdivision.

5.13 (b) In addition to any other penalty allowed by law, a violation of subdivision 2, clause
5.14 (1), shall result in a civil penalty of not more than \$1,000 per advertisement, to be paid to
5.15 the entity that is authorized to bring the action under this section.

5.16 (c) In addition to any other penalty allowed by law, a violation of subdivision 2, clause
5.17 (2) or (3), shall result in a civil penalty of not more than \$1,000 per animal, to be paid to
5.18 the entity that is authorized to bring the action under this section.

5.19 Sec. 3. **[504B.120] PROHIBITED FEES.**

5.20 Subdivision 1. **Disclosure of fees.** A landlord must disclose all nonoptional fees in the
5.21 lease agreement. The sum total of rent and all nonoptional fees must be described as the
5.22 Total Monthly Payment and be listed on the first page of the lease. A unit advertised for a
5.23 residential tenancy must disclose the nonoptional fees included with the total amount for
5.24 rent in any advertisement or posting. For purposes of this subdivision, charges billed to the
5.25 tenant including utility charges, related utility fees, and charges under section 504B.215,
5.26 are not considered rent or nonoptional fees.

5.27 Subd. 2. **Penalties.** A landlord who violates this section is liable to the residential tenant
5.28 for treble damages and the court may award the tenant reasonable attorney fees.

5.29 **EFFECTIVE DATE.** This section applies to leases signed on, or after August 1, 2024.

5.30 Sec. 4. Minnesota Statutes 2022, section 504B.178, subdivision 4, is amended to read:

5.31 Subd. 4. **Damages.** Any landlord who fails to:

- 6.1 (1) provide a written statement within three weeks of termination of the tenancy;
- 6.2 (2) provide a written statement within five days of the date when the tenant leaves the
6.3 building or dwelling due to the legal condemnation of the building or dwelling in which the
6.4 tenant lives for reasons not due to willful, malicious, or irresponsible conduct of the tenant;
- 6.5 ~~or~~
- 6.6 (3) transfer or return a deposit as required by subdivision 5; or
- 6.7 (4) provide the tenant with notice for an initial inspection and move-out inspection as
6.8 required by section 504B.182, and complete an initial inspection and move-out inspection
6.9 when requested by the tenant,
6.10 after receipt of the tenant's mailing address or delivery instructions, as required in subdivision
6.11 3, is liable to the tenant for damages in an amount equal to the portion of the deposit withheld
6.12 by the landlord and interest thereon as provided in subdivision 2, as a penalty, in addition
6.13 to the portion of the deposit wrongfully withheld by the landlord and interest thereon.

6.14 **Sec. 5. [504B.182] INITIAL AND FINAL INSPECTION REQUIRED.**

6.15 Subdivision 1. **Initial inspection.** (a) At the commencement of a residential tenancy, or
6.16 within 14 days of a residential tenant occupying a unit, the landlord must notify the tenant
6.17 of their option to request an initial inspection of the residential unit for the purposes of
6.18 identifying existing deficiencies in the rental unit to avoid deductions for the security deposit
6.19 of the tenant at a future date. If the tenant requests an inspection, the landlord and tenant
6.20 shall schedule the inspection at a mutually acceptable date and time.

6.21 (b) In lieu of an initial inspection, when a tenant agrees, a landlord may provide written
6.22 acknowledgment to the tenant of photos or videos of a rental unit and agree to the condition
6.23 of the rental unit at the start of the tenancy.

6.24 Subd. 2. **Move-out inspection.** Within a reasonable time after notification of either a
6.25 landlord or residential tenant's intention to terminate the tenancy, or before the end of the
6.26 lease term, the landlord shall notify the tenant in writing of the tenant's option to request an
6.27 initial inspection and of the tenant's right to be present at the inspection. At a reasonable
6.28 time, but no earlier than five days before the termination or the end of the lease date, or day
6.29 the tenant plans to vacate the unit, the landlord, or an agent of the landlord, shall, upon the
6.30 request of the tenant, make a move-out inspection of the premises. The purpose of the
6.31 move-out inspection shall be to allow the tenant an opportunity to remedy identified
6.32 deficiencies, in a manner consistent with the rights and obligations of the parties under the
6.33 rental agreement, in order to avoid deductions from the security deposit. If a tenant chooses

7.1 not to request an initial inspection, the duties of the landlord under this subdivision are
7.2 discharged. If an inspection is requested, the parties shall attempt to schedule the inspection
7.3 at a mutually acceptable date and time.

7.4 Subd. 3. **Other requirements under law.** Nothing in this section changes the
7.5 requirements or obligations under any other section of law, including but not limited to
7.6 sections 504B.178, 504B.185, 504B.195, or 504B.271, 504B.375, and 504B.381.

7.7 Subd. 4. **Waiver.** Any provision, whether oral or written, of any lease or other agreement,
7.8 whereby any provision of this section is waived by a tenant, is contrary to public policy and
7.9 void.

7.10 Sec. 6. Minnesota Statutes 2022, section 504B.211, subdivision 2, is amended to read:

7.11 Subd. 2. **Entry by landlord.** Except as provided in subdivision 4, a landlord may enter
7.12 the premises rented by a residential tenant only for a reasonable business purpose and after
7.13 making a good faith effort to give the residential tenant reasonable notice under the
7.14 circumstances of not less than 24 hours in advance of the intent to enter. The notice must
7.15 specify a time or anticipated window of time of entry and the landlord may only enter
7.16 between the hours of 8:00 a.m. and 8:00 p.m. unless the landlord and tenant agree to an
7.17 earlier or later time. A residential tenant may not waive and the landlord may not require
7.18 the residential tenant to waive the residential tenant's right to prior notice of entry under
7.19 this section as a condition of entering into or maintaining the lease.

7.20 Sec. 7. Minnesota Statutes 2022, section 504B.211, subdivision 6, is amended to read:

7.21 Subd. 6. **Penalty.** If a landlord ~~substantially~~ violates ~~subdivision 2~~ this section, the
7.22 residential tenant is entitled to a penalty which may include a rent reduction up to full
7.23 rescission of the lease, recovery of any damage deposit less any amount retained under
7.24 section 504B.178, and up to a ~~\$100~~ \$500 civil penalty for each violation. ~~If a landlord~~
7.25 ~~violates subdivision 5, the residential tenant is entitled to up to a \$100 civil penalty for each~~
7.26 ~~violation and reasonable attorney fees.~~ A residential tenant ~~shall~~ may follow the procedures
7.27 in sections 504B.381, 504B.385, and 504B.395 to 504B.471 to enforce the provisions of
7.28 this section. A violation of this section by the landlord is a violation of section 504B.161.

7.29 **EFFECTIVE DATE.** This section applies to matters commenced on or after August
7.30 1, 2024.

8.1 Sec. 8. **[504B.268] RIGHT TO COUNSEL IN PUBLIC HOUSING; BREACH OF**
8.2 **LEASE EVICTION ACTIONS.**

8.3 Subdivision 1. **Right to counsel.** A defendant in public housing subject to an eviction
8.4 action under sections 504B.281 to 504B.371 alleging breach of lease under section 504B.171
8.5 or 504B.285 who is financially unable to obtain counsel has the right to counsel appointed
8.6 by the court. The complaint required by section 504B.321 shall include the notice on the
8.7 first page of the complaint in bold 12-point type: "If financially unable to obtain counsel,
8.8 the defendant has the right to a court-appointed attorney." At the initial hearing, the court
8.9 shall ask the defendant if the defendant wants court-appointed counsel and shall explain
8.10 what such appointed counsel can accomplish for the defendant.

8.11 Subd. 2. **Qualifications.** Counsel appointed by the court must (1) have a minimum of
8.12 two years' experience handling public housing evictions; (2) have training in handling public
8.13 housing evictions; or (3) be supervised by an attorney who meets the minimum qualifications
8.14 under clause (1) or (2).

8.15 Subd. 3. **Compensation.** By January 15, 2024, and every year thereafter, the chief judge
8.16 of the judicial district, after consultation with public housing attorneys, legal aid attorneys,
8.17 and members of the private bar in the district, shall establish a compensation rate for attorney
8.18 fees and costs associated with representation under subdivision 1. The compensation to be
8.19 paid to an attorney for such service rendered to a defendant under this subdivision may not
8.20 exceed \$5,000, exclusive of reimbursement for expenses reasonably incurred, unless payment
8.21 in excess of that limit is certified by the chief judge of the district as necessary to provide
8.22 fair compensation for services of an unusual character or duration.

8.24 **LEASE COVENANTS AND REPAIRS IN RESIDENTIAL TENANCY**

8.25 Section 1. Minnesota Statutes 2022, section 504B.161, subdivision 1, is amended to read:

8.26 Subdivision 1. **Requirements.** (a) In every lease or license of residential premises, the
8.27 landlord or licensor covenants:

8.28 (1) that the premises and all common areas are fit for the use intended by the parties;

8.29 (2) to keep the premises in reasonable repair during the term of the lease or license,
8.30 except when the disrepair has been caused by the willful, malicious, or irresponsible conduct
8.31 of the tenant or licensee or a person under the direction or control of the tenant or licensee;

9.1 (3) to make the premises reasonably energy efficient by installing weatherstripping,
9.2 caulking, storm windows, and storm doors when any such measure will result in energy
9.3 procurement cost savings, based on current and projected average residential energy costs
9.4 in Minnesota, that will exceed the cost of implementing that measure, including interest,
9.5 amortized over the ten-year period following the incurring of the cost; ~~and~~

9.6 (4) to maintain the premises in compliance with the applicable health and safety laws
9.7 of the state, and of the local units of government where the premises are located during the
9.8 term of the lease or license, except when violation of the health and safety laws has been
9.9 caused by the willful, malicious, or irresponsible conduct of the tenant or licensee or a
9.10 person under the direction or control of the tenant or licensee; and

9.11 (5) to supply or furnish heat at a minimum temperature of 68 degrees Fahrenheit when
9.12 the temperature is below 60 degrees Fahrenheit between October 1 through April 30, unless
9.13 a utility company requires and instructs the heat to be reduced.

9.14 (b) The parties to a lease or license of residential premises may not waive or modify the
9.15 covenants imposed by this section.

9.16 Sec. 2. Minnesota Statutes 2022, section 504B.375, subdivision 1, is amended to read:

9.17 Subdivision 1. **Unlawful exclusion or removal.** (a) This section applies to actual or
9.18 constructive removal or exclusion of a residential tenant which may include the termination
9.19 of utilities or the removal of doors, windows, or locks. A residential tenant to whom this
9.20 section applies may recover possession of the premises as described in paragraphs (b) to
9.21 (e).

9.22 (b) The residential tenant shall present a verified petition to the district court of the
9.23 judicial district of the county in which the premises are located that:

9.24 (1) describes the premises and the landlord;

9.25 (2) specifically states the facts and grounds that demonstrate that the exclusion or removal
9.26 was unlawful, including a statement that no writ of recovery of the premises and order to
9.27 vacate has been issued under section 504B.345 in favor of the landlord and against the
9.28 residential tenant and executed in accordance with section 504B.365; and

9.29 (3) asks for possession.

9.30 (c) If it clearly appears from the specific grounds and facts stated in the verified petition
9.31 or by separate affidavit of the residential tenant or the residential tenant's attorney or agent

10.1 that the exclusion or removal was unlawful, the court shall immediately order that the
10.2 residential tenant have possession of the premises.

10.3 (d) The residential tenant shall furnish security, if any, that the court finds is appropriate
10.4 under the circumstances for payment of all costs and damages the landlord may sustain if
10.5 the order is subsequently found to have been obtained wrongfully. In determining the
10.6 appropriateness of security, the court shall consider the residential tenant's ability to afford
10.7 monetary security.

10.8 (e) The court shall direct the order to the sheriff of the county in which the premises are
10.9 located and the sheriff shall execute the order immediately by making a demand for
10.10 possession on the landlord, if found, or the landlord's agent or other person in charge of the
10.11 premises. If the landlord fails to comply with the demand, the officer shall take whatever
10.12 assistance may be necessary and immediately place the residential tenant in possession of
10.13 the premises. If the landlord, the landlord's agent, or other person in control of the premises
10.14 cannot be found and if there is no person in charge, the officer shall immediately enter into
10.15 and place the residential tenant in possession of the premises. The officer shall also serve
10.16 the order and verified petition or affidavit immediately upon the landlord or agent, in the
10.17 same manner as a summons is required to be served in a civil action in district court.

10.18 (f) The court administrator may charge a filing fee in the amount set for complaints and
10.19 counterclaims in conciliation court, subject to the filing of an inability to pay affidavit.

10.20 Sec. 3. Minnesota Statutes 2022, section 504B.381, subdivision 1, is amended to read:

10.21 Subdivision 1. **Petition.** A person authorized to bring an action under section 504B.395,
10.22 subdivision 1, may petition the court for relief ~~in cases of emergency involving the loss of~~
10.23 ~~running water, hot water, heat, electricity, sanitary facilities, or other essential services or~~
10.24 ~~facilities that the landlord is responsible for providing.:~~

10.25 (1) when a unit of government has issued a condemnation order or a notice of intent to
10.26 condemn; or

10.27 (2) in cases of emergency involving the following services and facilities when the landlord
10.28 is responsible for providing them:

10.29 (i) a serious infestation;

10.30 (ii) the loss of running water;

10.31 (iii) the loss of hot water;

10.32 (iv) the loss of heat;

- 11.1 (v) the loss of electricity;
- 11.2 (vi) the loss of sanitary facilities;
- 11.3 (vii) a nonfunctioning refrigerator;
- 11.4 (viii) if included in the lease, a nonfunctioning air conditioner;
- 11.5 (iv) if included in the lease, no functioning elevator;
- 11.6 (x) any conditions, services, or facilities that pose a serious and negative impact on

- 11.8 (xi) other essential services or facilities.

11.9 Sec. 4. Minnesota Statutes 2022, section 504B.381, subdivision 5, is amended to read:

11.10 Subd. 5. **Relief; service of petition and order.** Provided proof that the petitioner has

11.11 given the notice required in subdivision 4 to the landlord, if the court finds based on the

11.12 petitioner's emergency ex parte motion for relief, affidavit, and other evidence presented

11.13 that the landlord violated subdivision 1, then the court shall order that the landlord

11.14 immediately begin to remedy the violation and may order relief as provided in section

11.15 504B.425. The court and petitioner shall serve the petition and order on the landlord

11.16 personally or by mail as soon as practicable. The court shall include notice of a hearing and,

11.17 at the hearing, shall consider evidence of alleged violations, defenses, compliance with the

11.18 order, and any additional relief available under section 504B.425. The court and petitioner
