1.8	(a) The commissioner of human services, in consultation with the Minnesota Eligibility
1.9	System Executive Steering Committee, shall, using existing appropriations, develop content
1.10	to be included on the MNsure website explaining the TEFRA option under medical assistance
1.11	for applicants who indicate during the online application process that a child in the family
1.12	has a disability. The online content shall include a notification informing applicants that
1.13	the child with a disability may be eligible for medical assistance under the TEFRA option
1.14	even if the applicant does not qualify for medical assistance based on income. The notification
1.15	shall be displayed when the applicant is informed that the applicant is ineligible for medical
1.16	assistance based on the applicant's income.
