2.27 **K-12 EDUCATION**

2.28 Section 1. Minnesota Statutes 2017 Supplement, section 16A.152, subdivision 2, is
 2.29 amended to read:

2.30 Subd. 2. **Additional revenues; priority.** (a) If on the basis of a forecast of general fund
 2.31 revenues and expenditures, the commissioner of management and budget determines that
 2.32 there will be a positive unrestricted budgetary general fund balance at the close of the
 2.33 biennium, the commissioner of management and budget must allocate money to the following
 2.34 accounts and purposes in priority order:

2.35 (1) the cash flow account established in subdivision 1 until that account reaches
 2.36 \$350,000,000;

2.37 (2) the budget reserve account established in subdivision 1a until that account reaches
 2.38 ~~\$1,596,522,000~~ \$1,608,364,000;

2.39 (3) the amount necessary to increase the aid payment schedule for school district aids
 2.40 and credits payments in section 127A.45 to not more than 90 percent rounded to the nearest
 2.41 tenth of a percent without exceeding the amount available and with any remaining funds
 2.42 deposited in the budget reserve; and

3.6 (b) The amounts necessary to meet the requirements of this section are appropriated
3.7 from the general fund within two weeks after the forecast is released or, in the case of
3.8 transfers under paragraph (a), clauses (3) and (4), as necessary to meet the appropriations
3.9 schedules otherwise established in statute.

3.10 (c) The commissioner of management and budget shall certify the total dollar amount
3.11 of the reductions under paragraph (a), clauses (3) and (4), to the commissioner of education.
3.12 The commissioner of education shall increase the aid payment percentage and reduce the
3.13 property tax shift percentage by these amounts and apply those reductions to the current
3.14 fiscal year and thereafter.

3.17 Sec. 2. Minnesota Statutes 2016, section 122A.61, subdivision 1, is amended to read:

3.18 Subdivision 1. **Staff development revenue.** (a) A district is required to reserve an amount
3.19 equal to at least two percent of the basic revenue under section 126C.10, subdivision 2, for:

3.20 (1) teacher development and evaluation under section 122A.40, subdivision 8, or 122A.41,
3.21 subdivision 5;

3.22 (2) principal development and evaluation under section 123B.147, subdivision 3;

3.23 (3) professional development under section 122A.60; and

3.24 (4) in-service education for programs under section 120B.22, subdivision 2.

3.25 To the extent extra funds remain, staff development revenue may be used for staff
3.26 development plans, including plans for challenging instructional activities and experiences
3.27 under section 122A.60, and for curriculum development and programs, other in-service
3.28 education, teachers' mentoring under section 122A.70 and evaluation, teachers' workshops,
3.29 teacher conferences, the cost of substitute teachers for staff development purposes, preservice
3.30 and in-service education for special education professionals and paraprofessionals, and
3.31 other related costs for staff development efforts. A district may annually waive the
3.32 requirement to reserve their basic revenue under this section if a majority vote of the licensed

4.7 or establishing a different percentage reserve.

4.8 **Sec. 3. ONETIME COMPENSATION AND SCHOOL AID.**

4.9 Subdivision 1. **Temporary reduction.** \$50,000,000 in fiscal year 2019 is transferred
4.10 from the budget reserve under Minnesota Statutes, section 16A.152, subdivision 1a, to the
4.11 general fund.

4.12 Subd. 2. **School trust lands; appropriation for past activities.** \$50,000,000 in fiscal
4.13 year 2019 is appropriated from the general fund to the commissioner of education for
4.14 payment to schools under subdivision 3 for past activities conducted on school trust lands
4.15 that did not maximize deposits to the permanent school trust fund as specified under
4.16 Minnesota Statutes, section 84.027, subdivision 18, paragraph (b).

4.17 Subd. 3. **Student and school safety aid.** (a) For fiscal year 2019 only, concurrent with
4.18 the September 2018 apportionment from the school endowment fund to each school district
4.19 and charter school under Minnesota Statutes, section 127A.33, the commissioner must
4.20 distribute student and school safety aid equal to \$57.73 times the adjusted average daily
4.21 membership for the previous school year.

4.25 **Sec. 4. COMMUNITY SERVICE FUND; FUND TRANSFERS.**

4.26 (a) On June 30, 2018, and June 30, 2019, upon approval of the commissioner of education
4.27 and notwithstanding Minnesota Statutes, section 123B.79, 123B.80, or 124D.20, subdivision
4.28 10, a school district may permanently transfer any amount approved by the commissioner
4.29 from its community education reserve fund balance to its undesignated general fund.

4.30 (b) To the extent practicable, when making the fund transfer under this section, each
4.31 school district must abide by its board's fund balance policy, unless the funds are transferred
4.32 for an eligible use under Minnesota Statutes, section 124D.18.

5.1 (c) A school district requesting a fund transfer under this section must apply for the
 5.2 transfer in the form and manner specified by the commissioner.

5.3 **EFFECTIVE DATE.** This section is effective the day following final enactment.

5.5 **FEDERAL TAX CONFORMITY**

5.6 Section 1. Minnesota Statutes 2017 Supplement, section 270A.03, subdivision 5, is
 5.7 amended to read:

5.8 Subd. 5. **Debt.** (a) "Debt" means a legal obligation of a natural person to pay a fixed and
 5.9 certain amount of money, which equals or exceeds \$25 and which is due and payable to a
 5.10 claimant agency. The term includes criminal fines imposed under section 609.10 or 609.125,
 5.11 fines imposed for petty misdemeanors as defined in section 609.02, subdivision 4a, and
 5.12 restitution. A debt may arise under a contractual or statutory obligation, a court order, or
 5.13 other legal obligation, but need not have been reduced to judgment.

5.14 A debt includes any legal obligation of a current recipient of assistance which is based
 5.15 on overpayment of an assistance grant where that payment is based on a client waiver or
 5.16 an administrative or judicial finding of an intentional program violation; or where the debt
 5.17 is owed to a program wherein the debtor is not a client at the time notification is provided
 5.18 to initiate recovery under this chapter and the debtor is not a current recipient of food support,
 5.19 transitional child care, or transitional medical assistance.

5.20 (b) A debt does not include any legal obligation to pay a claimant agency for medical
 5.21 care, including hospitalization if the income of the debtor at the time when the medical care
 5.22 was rendered does not exceed the following amount:

5.23 (1) for an unmarried debtor, an income of ~~\$12,560~~ \$13,180 or less;

5.24 (2) for a debtor with one dependent, an income of ~~\$16,080~~ \$16,878 or less;

5.25 (3) for a debtor with two dependents, an income of ~~\$19,020~~ \$19,959 or less;

5.26 (4) for a debtor with three dependents, an income of ~~\$21,580~~ \$22,643 or less;

5.27 (5) for a debtor with four dependents, an income of ~~\$22,760~~ \$23,887 or less; and

5.28 (6) for a debtor with five or more dependents, an income of ~~\$23,730~~ \$24,900 or less.

5.29 For purposes of this paragraph, "debtor" means the individual whose income, together
 5.30 with the income of the individual's spouse, other than a separated spouse, brings the

6.1 individual within the income provisions of this paragraph. For purposes of this paragraph,
6.2 a spouse, other than a separated spouse, shall be considered a dependent.

6.3 (c) The commissioner shall adjust the income amounts in paragraph (b) by the percentage
6.4 determined pursuant to the provisions of section 1(f) of the Internal Revenue Code, except
6.5 that in section 1(f)(3)(B) the word "~~2014~~" "2017" shall be substituted for the word "~~1992~~."
6.6 ~~For 2016, the commissioner shall then determine the percent change from the 12 months~~
6.7 ~~ending on August 31, 2014, to the 12 months ending on August 31, 2015, and in each~~
6.8 ~~subsequent year, from the 12 months ending on August 31, 2014, to the 12 months ending~~
6.9 ~~on August 31 of the year preceding the taxable year. "2016."~~ The determination of the
6.10 commissioner pursuant to this subdivision shall not be considered a "rule" and shall not be

6.20 Subd. 7. **Internal Revenue Code.** Unless specifically defined otherwise, "Internal
6.21 Revenue Code" means the Internal Revenue Code of 1986, as amended through ~~December~~
6.22 ~~16, 2016~~ March 31, 2018.

6.23 **EFFECTIVE DATE.** This section is effective for taxable years beginning after December
6.24 31, 2017.

6.25 Sec. 3. Minnesota Statutes 2016, section 289A.08, subdivision 1, is amended to read:

6.26 Subdivision 1. **Generally; individuals.** (a) A taxpayer must file a return for each taxable
6.27 year the taxpayer is required to file a return under section 6012 of the Internal Revenue
6.28 Code or meets the requirements under paragraph (d) to file a return, except that:

6.29 (1) an individual who is not a Minnesota resident for any part of the year is not required
6.30 to file a Minnesota income tax return if the individual's gross income derived from Minnesota
6.31 sources as determined under sections 290.081, paragraph (a), and 290.17, is less than the
6.32 filing requirements for a single individual who is a full year resident of Minnesota; ~~and~~

7.1 (2) an individual who is a Minnesota resident is not required to file a Minnesota income
7.2 tax return if the individual's gross income derived from Minnesota sources as determined
7.3 under section 290.17, less the subtractions allowed under section 290.0132, subdivisions
7.4 12 and 15, is less than the filing requirements for a single individual who is a full-year
7.5 resident of Minnesota.

7.6 (b) The decedent's final income tax return, and other income tax returns for prior years
7.7 where the decedent had gross income in excess of the minimum amount at which an
7.8 individual is required to file and did not file, must be filed by the decedent's personal
7.9 representative, if any. If there is no personal representative, the return or returns must be
7.10 filed by the transferees, as defined in section 270C.58, subdivision 3, who receive property
7.11 of the decedent.

7.12 (c) The term "gross income," as it is used in this section, has the same meaning given it
7.13 in section 290.01, subdivision 20.

7.14 (d) The commissioner of revenue shall annually determine the gross income levels at
7.15 which individuals are required to file a return for each taxable year based on the amounts
7.16 that may be deducted under section 290.0803 and the personal and dependent exemptions
7.17 under section 290.0138.

7.18 **EFFECTIVE DATE.** This section is effective for taxable years beginning after December
7.19 31, 2017.

7.20 Sec. 4. Minnesota Statutes 2016, section 289A.08, subdivision 7, is amended to read:

7.21 Subd. 7. **Composite income tax returns for nonresident partners, shareholders, and**
7.22 **beneficiaries.** (a) The commissioner may allow a partnership with nonresident partners to
7.23 file a composite return and to pay the tax on behalf of nonresident partners who have no
7.24 other Minnesota source income. This composite return must include the names, addresses,
7.25 Social Security numbers, income allocation, and tax liability for the nonresident partners
7.26 electing to be covered by the composite return.

7.27 (b) The computation of a partner's tax liability must be determined by multiplying the
7.28 income allocated to that partner by the highest rate used to determine the tax liability for
7.29 individuals under section 290.06, subdivision 2c. Nonbusiness deductions, standard
7.30 deductions, or personal exemptions are not allowed.

7.31 (c) The partnership must submit a request to use this composite return filing method for
7.32 nonresident partners. The requesting partnership must file a composite return in the form

8.1 prescribed by the commissioner of revenue. The filing of a composite return is considered
8.2 a request to use the composite return filing method.

8.3 (d) The electing partner must not have any Minnesota source income other than the
8.4 income from the partnership and other electing partnerships. If it is determined that the
8.5 electing partner has other Minnesota source income, the inclusion of the income and tax
8.6 liability for that partner under this provision will not constitute a return to satisfy the
8.7 requirements of subdivision 1. The tax paid for the individual as part of the composite return
8.8 is allowed as a payment of the tax by the individual on the date on which the composite
8.9 return payment was made. If the electing nonresident partner has no other Minnesota source
8.10 income, filing of the composite return is a return for purposes of subdivision 1.

8.11 (e) This subdivision does not negate the requirement that an individual pay estimated
8.12 tax if the individual's liability would exceed the requirements set forth in section 289A.25.
8.13 The individual's liability to pay estimated tax is, however, satisfied when the partnership
8.14 pays composite estimated tax in the manner prescribed in section 289A.25.

8.15 (f) If an electing partner's share of the partnership's gross income from Minnesota sources
8.16 is less than the filing requirements for a nonresident under this subdivision, the tax liability
8.17 is zero. However, a statement showing the partner's share of gross income must be included
8.18 as part of the composite return.

8.19 (g) The election provided in this subdivision is only available to a partner who has no
8.20 other Minnesota source income and who is either (1) a full-year nonresident individual or
8.21 (2) a trust or estate that does not claim a deduction under either section 651 or 661 of the
8.22 Internal Revenue Code.

8.23 (h) A corporation defined in section 290.9725 and its nonresident shareholders may
8.24 make an election under this paragraph. The provisions covering the partnership apply to
8.25 the corporation and the provisions applying to the partner apply to the shareholder.

8.26 (i) Estates and trusts distributing current income only and the nonresident individual
8.27 beneficiaries of the estates or trusts may make an election under this paragraph. The
8.28 provisions covering the partnership apply to the estate or trust. The provisions applying to
8.29 the partner apply to the beneficiary.

8.30 (j) For the purposes of this subdivision, "income" means the partner's share of federal
8.31 adjusted gross income from the partnership modified by the additions provided in section
8.32 290.0131, subdivisions 8 to ~~10~~ 10 and 17, and the subtractions provided in: (1) section
8.33 290.0132, subdivision 9, to the extent the amount is assignable or allocable to Minnesota
8.34 under section 290.17; and (2) section 290.0132, subdivision 14. The subtraction allowed

9.1 under section 290.0132, subdivision 9, is only allowed on the composite tax computation
9.2 to the extent the electing partner would have been allowed the subtraction.

9.6 to read:

9.7 Subd. 14. **Reporting exempt interest and exempt-interest dividends.** (a) A regulated
9.8 investment company paying \$10 or more in exempt-interest dividends to an individual who
9.9 is a resident of Minnesota, or any person receiving \$10 or more of exempt interest or
9.10 exempt-interest dividends and paying as nominee to an individual who is a resident of
9.11 Minnesota, must make a return indicating the amount of the exempt interest or
9.12 exempt-interest dividends, the name, address, and Social Security number of the recipient,
9.13 and any other information that the commissioner specifies. The return must be provided to
9.14 the recipient by February 15 of the year following the year of the payment. The return
9.15 provided to the recipient must include a clear statement, in the form prescribed by the
9.16 commissioner, that the exempt interest or exempt-interest dividends must be included in
9.17 the computation of Minnesota taxable income. By June 1 of each year, the payer must file
9.18 a copy of the return with the commissioner.

104.23 (c) Class 2b rural vacant land consists of parcels of property, or portions thereof, that
104.24 are unplatted real estate, rural in character and not used for agricultural purposes, including
104.25 land used for growing trees for timber, lumber, and wood and wood products, that is not
104.26 improved with a structure. The presence of a minor, ancillary nonresidential structure as
104.27 defined by the commissioner of revenue does not disqualify the property from classification
104.28 under this paragraph. Any parcel of 20 acres or more improved with a structure that is not
104.29 a minor, ancillary nonresidential structure must be split-classified, and ten acres must be
104.30 assigned to the split parcel containing the structure. Class 2b property has a classification

106.20 (1) contiguous acreage that is less than ten acres in size and exclusively used in the
106.21 preceding year for raising or cultivating agricultural products; or

106.22 (2) contiguous acreage that contains a residence and is less than 11 acres in size, if the
106.23 contiguous acreage exclusive of the house, garage, and surrounding one acre of land was
106.24 used in the preceding year for one or more of the following three uses:

106.25 (i) for an intensive grain drying or storage operation, or for intensive machinery or
106.26 equipment storage activities used to support agricultural activities on other parcels of property
106.27 operated by the same farming entity;
