1.9	interest by contract or otherwise. This subdivision only applies to employees who are

1.11	(b) An employer who has a right to develop or utilize an invention or proposal
1.12	must make a substantial investment in the invention or proposal within 60 days of the
1.13	submission of the invention or proposal or forfeit all rights and interests in the invention
1.14	or proposal to the employee. This paragraph does not apply to inventions that relate to the
1.15	employer's existing product line, nor to any invention in which the employer has made
