1.5	COVID-19 Victims and Survivors Memorial Day; and
1.6	WHEREAS, COVID-19 (SARS-CoV-2), a novel coronavirus, is a deadly illness caused by
1.7	a virus that can transmit from person to person; and
1.8	WHEREAS, in 2020, COVID-19 began to spread throughout the world, creating a global
1.9	pandemic that has had a catastrophic impact on human life, our communities, and our economy;

1.11	WHEREAS, in March 2020, communities in every state began to experience increased loss
1.12	of life, and families lost fathers, mothers, brothers, sisters, sons, daughters, and neighbors from the
1.13	virus; and
1.14	WHEREAS, beginning in 2020, many across the United States were and continue to be
1.15	personally impacted by COVID-19, including mourning their loved ones and neighbors or suffering
1.16	from the unknown long-term health implications of the virus; and
1.17	WHEREAS, by February 2022, there were more than 76,700,000 known cases of the virus
