1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. Minnesota Statutes 2012, section 216B.2401, is amended to read:
1.6	216B.2401 ENERGY CONSERVATION <u>SAVINGS</u> POLICY GOAL.
1.7	The legislature finds that energy savings are an energy resource, and that
1.8	cost-effective energy savings are preferred over all other energy resources. The legislature
1.9	further finds that cost-effective energy savings should be procured systematically and
1.10	aggressively in order to reduce utility costs for businesses and residents, improve the
1.11	competitiveness and profitability of businesses, create more energy-related jobs, reduce the

1.12 economic burden of fuel imports, and reduce pollution and emissions that cause climate

1.13 <u>change</u>. Therefore, it is the energy policy of the state of Minnesota to achieve annual

1.14 energy savings equal to <u>at least</u> 1.5 percent of annual retail energy sales of electricity and

2.1	Subdivision 1. Energy planning. The legislature finds and declares that continued
2.2	growth in demand for energy will cause severe social and economic dislocations, and that
2.3	the state has a vital interest in providing for: increased efficiency in energy consumption,
2.4	the development and use of renewable energy resources wherever possible, and the
2.5	creation of an effective energy forecasting, planning, and education program.
2.6	The legislature further finds and declares that the protection of life, safety, and
2.7	financial security for citizens during an energy crisis is of paramount importance.
2.8	Therefore, the legislature finds that it is in the public interest to review, analyze, and
2.9	encourage those energy programs that will minimize the need for annual increases in fossil
2.10	fuel consumption by 1990 and the need for additional electrical generating plants, and
2.11	provide for an optimum combination of energy sources and energy conservation consistent
2.12	with environmental protection and the protection of citizens.
2.13	The legislature intends to monitor, through energy policy planning and
2.14	implementation, the transition from historic growth in energy demand to a period when
2.15	demand for traditional fuels becomes stable and the supply of renewable energy resources

3.2	RESOURCES; INTERIM ACTIVITY.
3.3	The division of energy resources of the Department of Commerce must conduct
3.4	public meetings with stakeholders and members of the public during the interim between
3.5	the 2013 and 2014 regular legislative sessions and shall produce a report on findings and
3.6	legislative recommendations to accomplish the following purposes:
3.7	(1) clarify statewide energy-savings policies and utility energy-savings goals;
3.8	(2) maximize cost-effective energy savings, including energy savings of large
3.9	customers;
3.10	(3) maximize carbon reductions and economic benefits from energy efficiency and
3.11	conservation improvements;
3.12	(4) minimize total utility costs and rate impacts for ratepayers in all sectors;
3.13	(5) determine appropriate funding sources for nonconservation projects and
3.14	programs, including cogeneration projects; and
3.15	(6) determine the appropriate consideration in the integrated resource planning and
3.16	certificate of need processes of the requirement for energy conservation efforts, including
